Ms. Rawls,

Since the clock is running on a response, I will comment briefly on the allegations. I will be retaining counsel and submitting an affidavit that will expand on these comments.

First, your assertion that I am a resident of NJ is incorrect. I am not and never have been a resident in NJ.

Second, your allegation that I participated in a "straw man scheme" is false. I have not ever and would not if asked, participate in such a scheme. I have participated in the political process for over 40 years as your records should show and have a better than average understanding of campaign funding legal issues. My first Secret Service clearance was for President Carter when I helped his staff during an SC visit. I have been a local office holder for 8 years and have been involved with a number of campaigns so I understand campaign fundraising requirements.

Third, I do not and have not supported anyone that I would not vote for. I met Senator Machin



when he was Governor long before I met Adam Victor. I was and still am a supporter of his and was glad of the opportunity to support him then and will continue to do so in the future.

Lastly, all of the payments made to me by any of the listed persons or companies, were for Finance & Risk management consulting services. Those payments were invoiced, reported as income to me via 1099 and taxes paid on them. My engagement with those companies ended in March of 2013 and I have not been engaged by them since that time.
