Complaint against Scott Taylor, individually, and Scott Taylor for Congress, John G. Selph, in his official capacity as treasurer; and Special Operations OPSEC Political Action Committee and Education Fund, Michael Smith, in his official capacity as treasurer, and Scott W. Taylor in his capacity as President and sole controlling member.

To Whom It May Concern:

Pursuant to 52 U.S.C. § 30109 and 11 C.F.R. § 111.4, Lisa Clarkson files this Complaint against Scott Taylor, an announced candidate for the Republican nomination for the House of Representatives from the Second District of Virginia and against Scott Taylor for Congress, John Selph, in his official capacity as Treasurer; and against Special Operations OPSEC Political Action Committee and Education Fund Inc., Michael Smith in his official capacity as Treasurer, and Scott W. Taylor in his capacity as President and sole controlling member (collectively, "Respondents").

Complainant is an individual citizen, a resident of the 2d congressional district of Virginia and respondent is a member of the Virginia House of Delegates. This complaint is filed in my individual capacity as a citizen of the Commonwealth of Virginia, and is a supplement to my complaint received by your office on June 1, 2016.

Respondent continues to be in violation of federal law, evidencing a flagrant disregard of the statutes and regulations that govern campaigns and committees as more fully detailed below.

Respondent Scott Taylor has a pattern and a history of violating federal law.

I. Respondent Scott Taylor repeatedly ignored federal law and failed to file mandatory reports of receipts and disbursements pursuant to 52 U.S.C. §30104(a)(2) and (i) when he was a candidate for Congress in 2010 and for *five* years thereafter.

II. Respondent Scott Taylor has evidenced a similar pattern of ignoring federal law in the 2016 election cycle, having committed multiple violations of federal law governing federal campaigns and candidates.

It is unlawful for a congressional candidate to solicit and accept contributions from a federal government contractor. The individuals listed above are easily identified as heads of organizations that depend on and/or actively solicit and receive funds from federal government contracts. See 52 U.S.C. §30119; 11 C.F.R. §115.1(a) and 115.2.

III. Respondent Scott Taylor repeatedly ignores federal law and fails to comply with the mandatory reports of receipts and disbursements pursuant to 52 U.S.C. §30104(a)(4) as the controlling member of several political committees initiated in 2012 and for four years thereafter.

While serving as President of Special Operations OPSEC, Respondent failed to comply with the reporting requirements for receipts and disbursements of political committees.

No other reports have been filed with this Commission, or the Internal Revenue Service regarding Special Operations OPSEC Political Committee, connected entity Special Operations OPSEC Education Fund Inc., EIN# 46-0725135.

Only a committee which will no longer receive contributions or make disbursements may terminate. See 52 U.S.C. §30103(d)(1)(I); C.F.R. § 102.3(a)(1). From the reported termination date of 02/28/2013, up and through the present, Respondent continues to solicit funds for Special Operations OPSEC, and has not filed any reports with the Commission.

IV. Respondent Scott Taylor repeatedly ignores federal law and fails to comply with fundraising guidelines pursuant to 52 U.S.C. §30125(e)(1) and (4) as the President and controlling member of several Special Operations OPSEC committees.

Respondent has served as president of Special Operations OPSEC since 2012, up and through the present.

As indicated above, nothing has been filed on behalf of Special Operations OPSEC since April of 2013 declaring a termination date of 02/28/2013. Although, Respondent has been actively soliciting contributions since the declared date of termination of 02/28/2013. See Direct Emails from info@scotttaylor.org Exhibit #3.

In fact, Special Operations OPSEC Education Fund has been actively soliciting contributions for the Scott Taylor for Congress committee as evidenced by posts on the OPSEC Team Facebook page on March 4 and May 8, 2016.

Respondent has once again completely ignored federal election law by using Special Operations OPSEC's name and resources to fraudulently solicit funds for his congressional campaign (See 52 U.S.C. §§30124(b) and 30125(c); 11 C.F.R. §§300.52 and 300.65).

Arguments and Authorities

Respondent, Scott Taylor, makes absolutely *no* effort to conform to the federal laws, whether in his first campaign for Congress in 2010, or as President of Special Operations OPSEC Education Fund from 2012 to present, or in his current campaign for Congress (2016). He does not believe these laws apply to him.


Respondent, Scott Taylor, willfully disregards the campaign finance laws and regulations not only as a candidate, but also as the president and controlling member of several committees which have been collecting and soliciting money, yet not reporting same with either this Committee or the Internal Revenue Service.

Respondents need to be held accountable for their actions and omissions, and need to account for all of the monies received and disbursed by these organizations.

Conclusion

Upon information and belief, and based upon the facts contained in this Complaint, Respondents Scott Taylor, individually, and Scott Taylor for Congress, John G. Selph, in his official capacity as treasurer; Special Operations OPSEC Political Action Committee and Education Fund, Michael Smith, in his official capacity as treasurer, and Scott W. Taylor in his capacity as President and sole controlling member; have flagrantly violated federal law and should be audited to fully account for years of unreported contributions to a supposed not-for-profit organization.

State Del. Scott Taylor, a former Navy SEAL, said Saturday he's seeking the Republican Party nomination to replace U.S. Rep. Scott Rigell in the state's 2nd Congressional District.

Taylor, 36, is the second GOP contender to step forward since Rigell, a three-term incumbent, said Thursday he would not seek reelection. Taylor already has experience running for Congress, having competed unsuccessfully against Rigell in a six-man Republican primary in 2010. Rigell went on to win the general election, ousting incumbent Democrat Glenn Nye.

Taylor said among his primary concerns are ending the automatic cuts in national defense – known as sequestration – improving the national economy and putting a stronger focus on computer science education among young students.

"We're in a two-year reprieve now with sequester. But it's coming back," he said. "I want to be a strong voice for our military. Not just spending unnecessarily but, on the flip side, not having indiscriminate cuts."

Taylor said the U.S. has to step up education programs to compete in a global high-tech economy.

"We should be exposing kids to data science in elementary school. ... Instead of just playing games they should be designing them," he said.

The candidate said he agrees with Rigell's efforts to expand his base of supporters beyond traditional Republicans.

"That's exactly how I operate," Taylor said. "When I'm representing people, I represent everyone. I go to black, white, brown events. Latino or gay events. I go everywhere. I think that's what you should do."

Taylor, who is a real estate broker, has been a television commentator and wrote a 2013 book, "Trust Betrayed: Barack Obama, Hillary Clinton, and the Selling Out of America's National Security."

He was elected to the state House of Delegates in 2013 and was unopposed when re-elected in November. He had considered running for lieutenant governor in 2017 but said those plans are on hold now that he's seeking the 2nd District post.

He joins Pat Cardwell, an attorney and first-time candidate, who announced Friday he's also is seeking the GOP nomination. Republican officials haven't decided whether they will choose their nominee in a June primary or a convention.

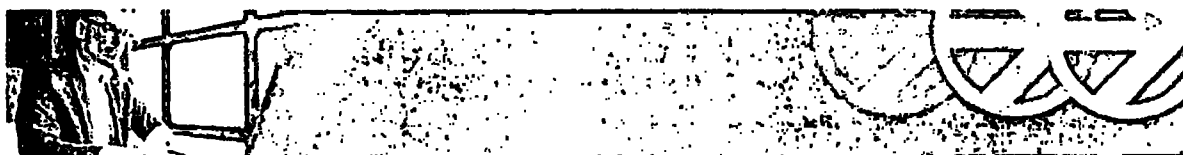

My Decision

The last few days have been encouraging, to say the least.

I want to tell you about my decision to seek election to the US House of Representatives in Virginia's Second District.

First, let me address my exploration of the Lieutenant Governor's office. It was very humbling, after only being in my third year in Richmond, to have an abundance of conservative elected officials and activists from around Virginia ask me to run. However, before

making this decision official, I thought about what Congressman Rigell's plans for the future might be. After all, I competed with him in the 2010 primary. His decision last week to not to seek reelection has made me reconsider where I could best serve and be impactful on the issues that we all hold important.

As many of you know, I'm passionate about national and international issues. I have written a book about how our national security and foreign policies are dangerously headed down the wrong path. Upon Rep. Rigell's announcement, we did a snapshot poll to the district, where well over two to one voters said I should run for Congress. Friday night we asked folks to come over to Town Center and sign petitions and just 15 hours later on Saturday 300 supporters and four news crews showed up. Clearly, there is interest in - and excitement about - this campaign.

I understand very well that in a power vacuum there will be jockeying for position. Some will win, some will lose, and sometimes, entrenched politicians become insecure and make horrible decisions based on bad advice. I am blessed to have an amazingly loyal family, circle of friends, and supportive base. Your belief in what we can accomplish together gives me strength and I promise to stand shoulder-to-shoulder with you in any fight. I will never abandon this community. I will fight hard and I will never quit.

Everyone knows in their hearts that Washington D.C. is broken and people are demanding real, honest change. Those who have been in Washington for a long time have failed to stem sequestration and the weakening of our national security, stop crushing regulatory burdens, and the unrelenting economic hardships on America's families. Together we will be a force multiplier to change America and our community. Those who show up govern us. Join us

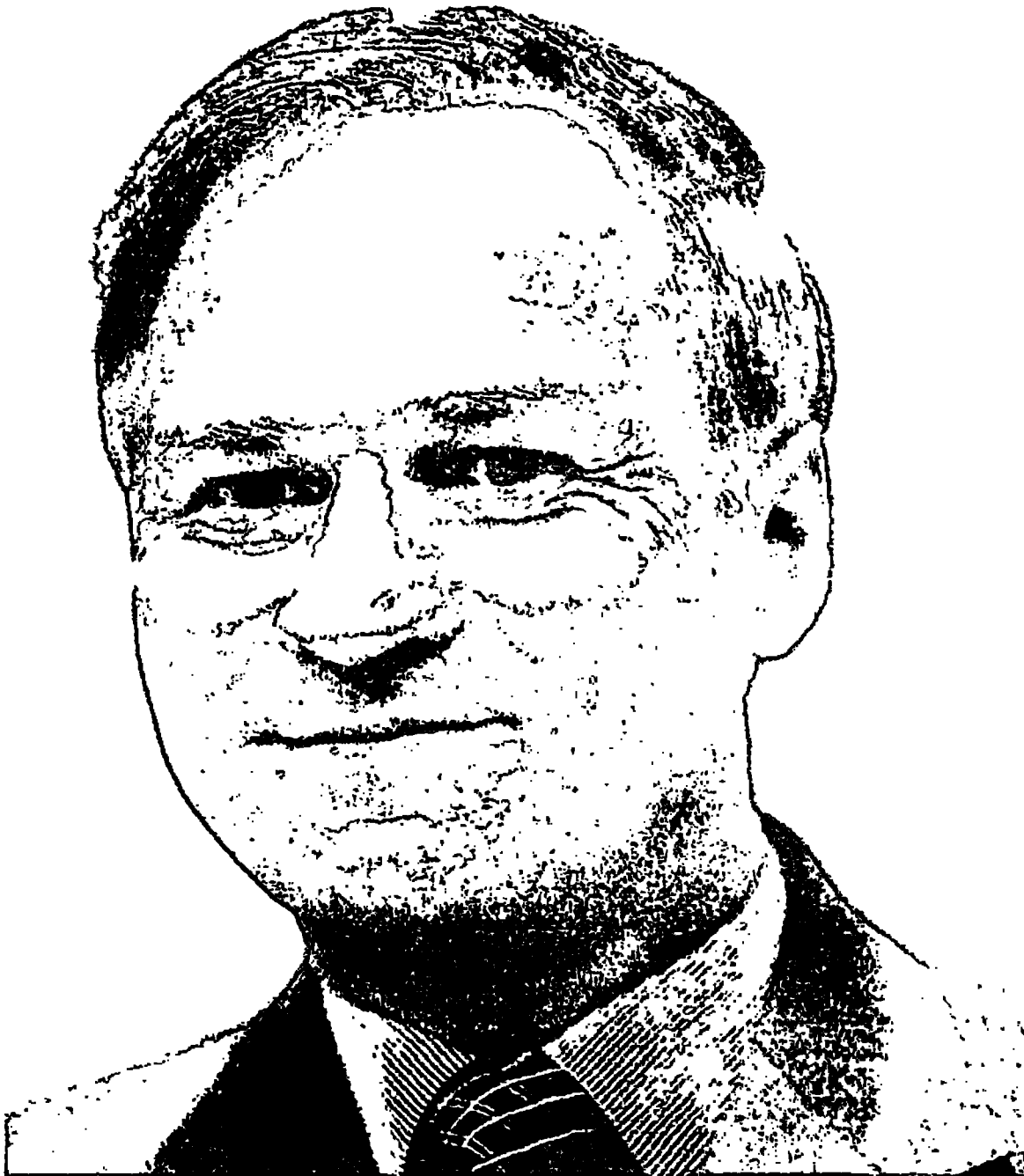

State Del. Scott Taylor went directly to U.S. Rep. Randy Forbes' Republican supporters in Chesapeake earlier this week, sponsoring more than 5,500 automated calls urging the voters to tell Forbes to run for re-election in his hometown rather than switch to the nearby 2nd Congressional District.

Taylor, a Virginia Beach Republican seeking the 2nd District seat, wants to stop Forbes from switching from the 4th District, which he has represented in Congress since 2001.

In the 75-second recorded message, a woman who calls herself "Erin" refers to Forbes as "our congressman" and says he "is the only Republican who can win our district." At the end of the message, Taylor is heard saying his campaign paid for the Sunday-night calls.

Forbes is contemplating the switch because this year's redrawing of congressional district boundaries has converted the 4th from a strong Republican region to one where Democrats have a majority. The GOP-leaning 2nd, where Virginia Beach is the largest city, is an open seat because three-term incumbent Scott Rigell is not running this year. Rigell has said he'll endorse Forbes if he moves to the 2nd.

Taylor's phone call to Chesapeake voters, selected because they voted in the 2012 GOP presidential primary, warns that a Democrat will be elected in the 4th if Forbes doesn't run there.

"Over the years, we've invested millions of dollars, time and energy into Randy Forbes. And we have fought for him in past campaigns," the woman said. "This is a time when Randy needs to fight for us – not run off to Virginia Beach because it may be easier to get elected over there. Leaders put themselves at risk for their people – not the other way around."

When asked about the phone calls Wednesday, Forbes spokeswoman Hailey Sadler said in an email: "Congressman Forbes continues to be overwhelmed by the enormous outpouring of support from across the 2nd district. The only thing we've heard about the robocalls is how annoyed people were to receive them."

The technique used by Taylor's campaign is known as a "push poll." It's meant to spread an idea as much as to collect public opinion. The speaker presents an issue with a strong point of view and then asks the recipient whether he or she agrees.

In this case, the Chesapeake voters were asked whether they wanted Forbes to "run to be our congressman and fight for us" or "leave Chesapeake behind and go run for Congress in Virginia Beach."

Of the 5,557 calls, 437 people answered the question, with 97 percent saying Forbes should stay, according to a report by RoboCent, a Virginia Beach-based autodial firm hired by Taylor.

Scott Weldon, spokesman for Taylor's campaign, acknowledged the calls were intended to spread his candidate's views and reach people who might not know about Forbes' quandary.

"We obviously want people to know this is something that is being seriously entertained," Weldon said.

Taylor conducted a separate push poll in Virginia Beach, where more than 2,400 GOP voters were contacted Sunday and Monday. Taylor, in a recorded message, introduced himself as a candidate, lambasted the current Congress and criticized Forbes for considering giving up his 4th District seat to run in the 2nd.

The recipients were then asked whether, "based on what you know," they would support Taylor or Forbes. Ninety-five percent said they favored Taylor, according to RoboCent.

Forbes, who hasn't spoken publicly about his plans, has been attempting to build support among political leaders and business executives in the 2nd. He and his supporters argue that if he's not returned to Congress, the defense-heavy region will lose its only senior lawmaker

on a crucial panel overseeing the Pentagon. Forbes is chairman of the House Armed Services Committee's Seapower and Projection Forces subcommittee, which oversees Navy and Marine Corps programs.

Some others, including Virginia Beach Sheriff Ken Stolle, a Republican, oppose Forbes making the switch, saying the district should choose one of its own. The U.S. Constitution requires members of Congress to live in their states but not their specific districts.
