Re: Complaint against Tom Nelson & Nelson for Wisconsin

Dear Counsel,

I write to urge the Federal Election Commission ("FEC") to investigate and take appropriate enforcement actions to address apparent violations of the Federal Election Campaign Act, as amended, 52 U.S.C. § 30101 *et seq.* ("FECA") and FEC regulations 11 C.F.R. § 1.1 *et seq.*, by Tom Nelson and his campaign committee, Nelson for Wisconsin (FEC ID# C00614115). Specifically, upon publicly available information and upon information and belief, there is reason to believe that Tom Nelson and Nelson for Wisconsin have violated 52 U.S.C. § 30120(d) and 11 C.F.R. § 110.11 for failing to include proper independent expenditure disclaimers. In addition, Tom Nelson and Nelson for Wisconsin failed to file required independent expenditure reports in accordance with 52 U.S.C. § 30104 and 11 C.F.R. §§ 104.4. and 109.

Introduction

Tom Nelson and his campaign committee are running a television advertisement mentioning presidential candidate Donald Trump's name and expressly advocating the defeat of Donald Trump in the general election.¹ By making such statements in the advertisement, Tom Nelson and his campaign committee triggered an independent expenditure in the federal race for United States President, thereby benefitting the Hillary for America campaign committee.

Nelson for Wisconsin campaign committee appears to have violated FECA and FEC regulations by not including the necessary independent expenditure disclaimer in the advertisement, and not timely filing a 48-hour independent expenditure report with the FEC. Furthermore, due to the content and timing of the advertisement at issue, it is also likely that Tom Nelson and Nelson for Wisconsin coordinated its efforts with the Hillary for America presidential campaign committee resulting in an excessive inkind contribution to the Hillary for America campaign committee.

Facts

On October 21, 2016 Tom Nelson and his campaign committee began televising an advertisement in the Green Bay, WI media market.² The 31second advertisement features Tom Nelson speaking directly to the camera. While the first 24 seconds of the advertisement feature content relevant to Tom Nelson's race for Wisconsin's 8th Congressional District, the closing of the ad only involves Tom Nelson expressly advocates for Donald Trump's defeat.

Specifically, at the end of the ad Tom Nelson states, "I approve this message because Donald Trump is dangerous and we can't let him become president." By ending his advertisement in this way, Tom Nelson and his campaign committee not only engage in express advocacy against Donald Trump, a candidate for United States President, but they associate the entirety of the advertisement with the message of preventing Donald Trump from becoming president. To put more simply, Tom Nelson's closing statement conditions all of the ad's content on not letting Donald Trump become president. Therefore, this is an advertisement not relating to Wisconsin's 8th Congressional District, but an advertisement against the election of presidential candidate Donald Trump.

Legal Analysis

A. Tom Nelson and Nelson for Wisconsin violated FECA and FEC regulations by failing to include the required disclaimers.

FECA and FEC regulations require candidate committees that issue public communications expressly advocating the election or defeat of a clearly identified federal candidate not directly involved in the candidate committee's race to carry a disclaimer identifying the sponsor of the communication and whether ad is coordinated with or independent of the candidate. See 11 C.F.R. § 110.11. The disclaimer requirements clearly apply to advertisements broadcast on television. See 11 C.F.R. § 100.26.

Without question the statement "I approve this message because Donald Trump is dangerous and we can't let him become president" constitutes express advocacy under *Buckley v. Valeo*, 424 U.S. 1 44 n.52 (1976) and FEC regulations at 11 C.F.R. 100.22. Furthermore, it cannot be argued that Tom Nelson and the Nelson Campaign did not clearly identify Donald Trump as a candidate for United States President and not as a

candidate for Wisconsin's 8th congressional district. *See* 11 C.F.R. § 100.17 ("clearly identified means the candidate's name...").

Tom Nelson and Nelson for Wisconsin have violated FECA and FEC regulations by failing to include the required disclaimers in the television advertisement, and therefore warrants a thorough investigation by the FEC.

B. Because Tom Nelson and Nelson for Wisconsin made expenditures associated with its advertisement in excess of \$1,000, it must file independent expenditure reports required by FECA and FEC regulations.

FEC regulations require any person who makes independent expenditures aggregating in excess of \$250 during a calendar year must file a signed statement or report with the FEC. *See* 11. C.F.R. § 109.10(b). Furthermore, persons who make independent expenditures aggregating \$1000 after the 20th day but more than 24 hours before the day of an election must report the expenditure within 24 hours after the expenditure is made. *See* 11. C.F.R. § 109.10(d).

Publicly available information indicates that Tom Nelson and Nelson for Wisconsin made expenditures associated with the advertisement at issue well in excess of \$1000.³ The expenditures include not only the dollar values ascribed to the buying of advertisement space but also the costs of the advertisement's filming and editing.

Accordingly, because Tom Nelson and Nelson for Wisconsin have made expenditures aggregating in excess of \$1,000 in relation to the advertisement which began airing on October 21, 2016, less than 20 days before the November 8, 2016 election, it must file 24 hour independent expenditure reports. Failure to file the required independent expenditure reports would constitute a violation of FECA and FEC regulations and would warrant a thorough investigation by the FEC.

In addition to the arguments provided above, it is reasonable for the FEC to inquire as to whether Tom Nelson and/or Nelson for Wisconsin impermissibly coordinated with Hillary for America when producing and airing the advertisement at issue, for if coordination occurred, the value of the add must be reported as an inkind contribution to Hillary for America, which would also constitute an excessive contribution. While it is not unusual for a candidate for the United States House of Representatives to mention the current candidate for United State President and link the presidential candidate to the House candidate's opponent, it is uncommon for a House candidate to air an independent advertisement entirely premised on expressly advocating

the defeat of a presidential candidate. This activity warrants thorough investigation by the FEC.

Conclusion

Tom Nelson and Nelson for Wisconsin's apparent failure to comply with FECA and FEC regulations warrants investigation by the FEC. Therefore, the FEC should immediately investigate this matter and find reason to believe that Tom Nelson and Nelson for Wisconsin have violated FECA and FEC regulations for the reasons set forth herein.
