RE: Complaint against Trump Make America Great Again Campaign

To Whom it Should Be Addressed:


In July, 2016, I made my first ever monetary contribution to a presidential campaign. Not being of wealthy means, I carefully reviewed my finances and came up with a figure I felt I could donate without causing financial harm to my household. I donated \$150.00 on the 22nd and had set to withdraw the same amount for the next three months. This meant it would end in October of 2016, just prior to the November elections.

In September, 2016, while sitting down to balance my bank account, I see two withdrawals made in July, instead of the one. I called the number provided on my bank statement and was directed to leave a message and someone would get back to me. I left a detailed message at that time, so when my call was not returned, I thought perhaps I had provided enough information in my message that they took care of it and I would receive a check in the mail. The following month, another withdrawal was made. I called again. This is the point that I began calling multiple times a month, sometimes speaking with a live individual and other times leaving messages. When November came around, another withdrawal was made plus overdraft fees were charged. I didn't plan for contributions passed October. The majority of my income is made during the months of June through September. I had only made contributions for July through October. From November forward, the withdrawals kept being withdrawn. The NSF fees were being withdrawn. My phone calling became regular and often. I requested all contributions be refunded because I felt deceived by their organization. With each live individual call, I would get the same scripted speech that someone would get back to me or a refund would be issued. I never heard anything from them until January 28, 2017. On this date, I was refunded seven of the eight withdrawals of \$150.00. There still remains one withdrawal plus the \$270.00 in NSF fees I was charged. I have continued to call these people and continue to get the same script. I am at the end of my patience dealing with them. I will never donate money ever again to any campaign. This first, and last, experience has been devastating and shows that no one can be trusted to do what is right.

I am asking for your help in this matter. I have enclosed a set of bank statements showing the withdrawals, NSF fees charged, and any refunds made, as well as a set of cell phone records. I am only able to send one copy of all documents as this is my second attempt at filing this complaint and can't afford to keep paying \$20 to send it in. I do not have an address for Trump Make America Great Again Campaign as everything was set up electronically. There are two telephone numbers listed with the withdrawals. Both will appear on my cell phone bills.

I look forward to hearing from you in the near future and thank you in advance for your time and consideration.
