

Please find enclosed Statements of Designation of Counsel on behalf of Scott Sayre, Chairman and Sayre Enterprises, Inc., with reference to the above referenced Complaint. On May 1, 2018, Respondent received notice of the complaint that is the subject of the MUR. Pursuant to 52 U.S.C. § 30109(a)(1), Respondent to MUR 7373 has the opportunity to demonstrate in writing within fifteen (15) days of notification that the Commission should take no further action. On behalf of Mr. Sayre and Sayre Enterprises, Inc., we respectfully request an extension of time to answer the allegations of the Complaint. Mr. Sayre is a candidate for Chairman of the 6<sup>th</sup> Congressional Republican Committee of Virginia and, as such, is preparing for a convention on May 19, 2018.
