**Re: Complaint Against One Tallahassee for Failing to Register as a Political Committee**

Federal Election Commission:


I am writing to submit a complaint against One Tallahassee, a Florida political committee, and its Chairperson and Treasurer, Jeremy Matlow, which, upon information and belief, has not timely registered with the Commission in accordance with 52 U.S.C. § 30103(a). One Tallahassee is located at 112 East 6th Avenue, Tallahassee, Florida 32301.

52 U.S.C. § 30101(4) defines “political committee” as “any committee, club, association, or other group of persons which receives contributions aggregating in excess of \$1,000 during a calendar year or which makes expenditures aggregating in excess of \$1,000 during a calendar year.” *See also* 11 C.F.R. § 100.5(a) (“Except as provided in 11 CFR 100.5 (b), (c) and (d), any committee, club, association, or other group of persons which receives contributions aggregating in excess of \$1,000 or which makes expenditures aggregating in excess of \$1,000 during a calendar year is a political committee.”). Political committees are required to file a Statement of Organization with the Commission within 10 days of becoming a political committee. 52 U.S.C. § 30103(a); 11 C.F.R. § 102.2(a)(1).

On or about August 12, 2024, One Tallahassee circulated a mailer, which promotes Presidential candidate Kamala Harris. Attached hereto as **Exhibit A**. The mailer states, “This year, we can make History, again.” One third of this mailer is dedicated to Kamala Harris and, therefore, the purpose of this mailer is to promote a federal candidate. Based on information and belief, One Tallahassee exceeded the \$1,000 threshold on expenditures but failed to timely register with the Commission by filing a Statement of Organization. On August 8, 2024, One Tallahassee’s Chairperson and Treasurer, Jeremy Matlow, reported an expenditure for “Postage” to USPS of \$12,630.29. On August 9, 2024, One Tallahassee’s Chairperson and Treasurer, Jeremy Matlow, reported an expenditure for “Mail” to “Gandy” of \$7,127.53. A third of these amounts easily exceeds the \$1,000 threshold. *See* One Tallahassee’s August Reported Expenditures attached hereto as **Exhibit B**.


