GENERAL COUNSEL'S REPORT

BACKGROUND

79040131671
This matter originated as a referral from the Comptroller of the Currency after an examination of the respondent bank by the Comptroller's Office. The examination indicated that during 1978, a bank vice president, William F. Gardiner, may have worked for the Howell Heflin Senate Campaign on bank time and while on salary, and that the bank paid \$75 for tickets to a dinner for Ronnie Flipppo, who was a federal candidate that year.

On January 5, 1979, the Commission found reason to believe that the respondent national bank violated 2 U.S.C. §441b(a) by making in-kind and direct contributions to candidates. The bank answered questions and Mr. Gardiner submitted an affidavit explaining their activities. (See attachment I) Additional information was required and the Commission then issued §437d orders to Mr. Gardiner and the bank. Both responded. (See attachment II)

EVIDENCE

The answers indicate that Mr. Gardiner's position at the bank, even prior to the Heflin campaign, involved development of new business that was primarily outside the bank. This job

required that he take potential customers out for meals and often be with them until late hours. Mr. Gardiner stated he worked more than the 40 standard hours per week, but also said that the nature of his work left him free time during the day and on weekends to work on the campaign. He stated that during his business meetings he never solicited campaign contributions or represented himself as a Heflin campaign worker. The bank was aware of Mr. Gardiner's activities for the campaign but considered it a private matter which did not interfere with his bank duties.

The Flippo Dinner was run by the local chamber of commerce as an "appreciation dinner" and the bank denied it was a fundraiser for Mr. Flippo's congressional campaign. The bank's check for the three dinner tickets, totalling \$75, was dated January 11, 1978 and Mr. Flippo submitted his statement of candidacy on February 25, 1978.

ANALYSIS

The evidence indicates that Mr. Gardiner was working full time and fulfilling his duties at the bank during the period when he did volunteer work for the Heflin campaign. Consequently, the bank was not in violation of 2 U.S.C. §441b(a) by its retention of Mr. Gardiner on full salary during the campaign period.

The evidence also indicates that the dinner tickets purchased by the bank were not in connection with an election. The dinner was an "appreciation dinner" not run by a campaign



committee and not run as a fundraiser for the Flippo campaign. See AO 78-4. Therefore, the purchase of these tickets was not a violation of §441b(a) by the bank.

RECOMMENDATION

1. Find no reasonable cause to believe that respondent violated 2 U.S.C. §441b(a).
2. Close the file and send the attached letter.

Before me, the undersigned authority, personally appeared William F. Gardiner, who being by me first duly sworn and being known to me deposes and says as follows:

My name is William F. Gardiner and I am a resident citizen of Colbert County and well over the age of 21 years.

I understand that the Federal Election Commission has made an inquiry of Mr. Edmond B. Johnson, Jr., former president and chief executive officer of the First National Bank in Tuscumbia, Alabama, concerning my activities with the Howell Heflin Senate campaign.

I was a former loan officer of the First National Bank in Tuscumbia and having had a heart attack, I preferred outside work to being in an office all day and requested that I be returned to public relations for the bank. During the Howell Heflin Senate campaign, I did work for now Senator Howell Heflin mostly in the afternoons, nights and weekends; occasionally calling on prospective customers for the bank and discussing politics with them as a side effect rather than as a primary reason for my connection with these individuals.


I can list hundreds of people that I called on for the bank from January 26, 1978, to my resignation in December, 1978. I worked past due loans in and out of the bank during the year 1978 as well as the public relations and new account duties I performed during the year 1978 for the First National Bank in Tuscumbia, Alabama.

I also acted as a governmental affairs liaison man for the First National Bank in Tuscumbia with the governor of the state of Alabama, state senators, state representatives, mayors of the various towns in Colbert County and County commission.

I make this affidavit for the purpose of clearing up any doubts concerning the letter and questions to Mr. Johnson from the Federal Election Commission dated January 11, 1979.

(1) I was in the hospital from approximately April 27, 1976 to May 11, 1976, and the entire period of hospitalization and convalescence was about six weeks.

(2) During the month of June 1976,

a. during convalescence I did some part time work by telephone and then I would work a couple hours a day, then half a day and sometime in June went back to full time work.

b. forty hours a week would have been considered to be full time work, however, I did not work on a 8 to 5 schedule or any set schedule. My duties involved primarily business development, personal relations, customer services and at times I would work on past due loans. Due to the nature of my employment, there would be times when I would take customers or customers we were seeking to breakfast early in the morning, to lunch or to dinner, which sometimes could be late at night. I did not keep definite hours but would work more than forty hours every week.

c. Answered above.

d. My arrangements at the Bank were with Mr. John Brignet, Chairman of the Board, who was at the Bank full time. Mr. Ed Johnson, President, also agreed to the arrangement.

e. Chairman of the Board. Also, President of Bank.

(3) a. Yes. I had an office at the Bank and I would work in and out of the Bank.

(4) Chairman of the Board. This was reported to him verbally. The exact date I do not know. Also, told President.

(5) \$15,000.00

(6) \$15,000.00, however, it was subsequently raised to \$18,500.00

(7) My duties were as explained in (2) a. above, however, for a while during 1977, I worked in the Bank, on the floor, as a Customer Service man primarily, and then served as a Loan Officer for a while due to the fact that some of the employees of the Bank had left.

(8) As stated in (7) above, however, after serving as a Loan Officer for a while and because of my previous heart attack, I requested to be returned to my former duties as Personal Relations, Business Development, etc., and was returned to this duty. After this I worked practically all of the time out of the Bank but checked in and out of the Bank at irregular times.

(9) Vice-President, and for a while I was a Loan Officer.

(10) Vice-President.

(11) a. The main purpose of the calls referred to was to seek new Bank customers. I have served as Mayor of the City of Tuscumbia for 18 years, served as President of the League of Municipalities for the State of Alabama, and have had an active interest in politics all my life. One of the subjects that generally presents itself when I am discussing anyone who knows me at all, will be politics of some nature, local, state or national. This is merely conversation just as sometimes we discuss sports or other current matters.

b. No.

c. It is difficult to describe in a few words the substance of a conversation. However, in seeking new customers you would ordinarily endeavor to find some line of conversation in which the prospect had an interest and work into the business at hand. Many times this would be over breakfast, lunch or dinner, and then lead the conversation into the possibility of establishing an account with our Bank.

d. No.

(12) December 1, 1978.

(13) a. Did not have a title but, in general, was a jack-of-all-trades. I would contact people I knew throughout the State by telephone and solicit their support of Mr. Heflin and most of this was done after 5 o'clock in the afternoon. I would also discuss with Mr. Heflin and appropriate campaign workers as to nature and type of advertising and this was generally done over the weekends, Saturdays and Sundays. I would work in his office in Tuscumbia when not engaged in Bank business, doing anything that I could do to assist

b. I did not report as such to anyone. I would discuss matters with Mr. Heflin when he was in town, sometimes by telephone at night, and I would discuss matters with the Campaign Manager, Mike House, mostly by telephone.

c. Mike House and Senator Heflin are both in the United States Senate Office Building, Washington, D. C., telephone number is 224-4124.

(14)a. January 3, 1979.

b. I am listed as a Special Assistant to Senator Heflin. I represent him in meetings in Alabama when he cannot attend, coordinate and supervise his Alabama offices and such other functions requested by Senator Heflin.

BACKGROUND

This matter was referred to the Commission by the Comptroller of the Currency in a letter dated November 6, 1978. On December 8, 1978, the Commission accepted the General Counsel's recommendation that a MUR file be opened and an investigation commence (pre-MUR 15).

EVIDENCE

A routine examination of the First National Bank, Tuscumbia, Alabama (FNB) in August, 1978 revealed that a bank vice president, William F. Gardiner, was contributing his service on a full-time basis to the ultimately successful senatorial campaign of Howell Heflin. The National Bank Examiner was able to determine that Mr. Gardiner was not in a vacation or leave status and drew his full salary (between \$17,000 and \$24,000 per annum) from the bank while working for the Heflin campaign. The precise length of time Mr. Gardiner worked on the campaign is not known; however, the examiner noted that Mr. Gardiner was working for Heflin for at least as long as the one month period of the examination. When this practice was discussed with bank officials, it was claimed that Mr. Gardiner's activities were good "public relations" for the bank.

The examination of FNB also revealed an expense check, dated January 11, 1978, payable to a bank director in the amount of seventy-five dollars, for the purchase of three tickets to a fundraiser for the congressional campaign of a Mr. Flipppo.

ANALYSIS

Section 441b(b)(2) of the Act includes in the definition of contribution, "services, or anything of value." Section 441b(a) prohibits national banks from making any contribution to any political campaign. The evidence presented indicates that the bank made a "contribution" of the services of one of its officers to a federal campaign and suggests a violation of the national bank contribution prohibition of 2 U.S.C. §441b (a).

Commission policy is not to proceed against possible §441b violations of less than \$100. While the contribution of \$75 to the Flipppo campaign is beneath this threshold, it was referred to us as part of a matter potentially involving an in-kind §441b contribution of several thousand dollars by the same respondent. In this context, we recommend including it as part of our investigation of this matter.

RECOMMENDATIONS

1. Find reason to believe that the First National Bank, Tuscumbia, Alabama, violated 2 U.S.C. §441b(a).
2. Approve the attached letter and the questions appended thereto.

During the course of a recent examination of the First National Bank in Tuscumbia, Alabama, conducted in August of 1978, National Bank Examiner Dale Wilson discovered facts which this Office believes may constitute violations of the Federal Election Campaign Act. A description of these facts is contained below and this matter is referred to you for whatever action you deem appropriate.

Examiner Wilson discovered that the Vice President of the bank, William F. Gardiner, was contributing his services to the election campaign of Mr. Heflin, a United States Senatorial candidate, while Mr. Gardiner was in a salaried status at the First National Bank in Tuscumbia, (Tuscumbia). The exact period of his services is not known, however, the time period of Gardiner's services to Mr. Heflin's campaign exceeded the one-month period of Examiner Wilson's examination. Examiner Wilson was able to verify that Gardiner was not on vacation, nor was he in a leave status while donating his services to Mr. Heflin's campaign. When Examiner Wilson discussed this with officials of the bank, they did not consider anything improper with it and, in fact, thought it would help them in the future if Mr. Heflin were elected. Subsequently, these officials claimed that Gardiner, by donating his services to Mr. Heflin's campaign, was working on public relations on behalf of the bank.

These facts appear to constitute a violation of the Federal Election Campaign Act, specifically, 2 U.S.C. 441b(2), as further clarified and defined by 18 U.S.C. 591(e)(1) and (4).

Additionally, Examiner Wilson discovered an expense check, dated January 11, 1978, payable to Director Beasley in the amount of \$75.00 for three tickets to a campaign fund-raising dinner for Mr. Flippo, a U. S. Congressional candidate. The voucher containing evidence of this expense check can be found at the Tuscumbia bank.

In a letter received by the Office of the General Counsel on November 14, 1978, the Comptroller of the Currency has alerted us to certain matters that appear to violate portions of the Act.

During an August, 1978 examination of the First National Bank, Tuscumbia, Alabama, it was discovered that a bank Vice President was contributing his services on a full-time basis to the ultimately successful senatorial campaign of Howell Heflin. This individual was not on vacation or leave status and received his full salary (between \$17,000 and \$24,000 per year) during this time. The length of time this officer worked on the Heflin campaign is not known. However, the time period was at least as long as the one month period of the bank examination.

When the National Bank Examiner discussed this with bank officials, they felt there was nothing improper with the arrangement; later, they claimed that it was good "public relations" for the bank.

Section 441b(b)(2) includes in the definition of contribution "services, or anything of value." Accordingly, the prohibition on contributions by a national bank of 2 U.S.C. 441b(a) appears to have been violated by this arrangement.

The examination also revealed an expense check, dated January 11, 1978, drawn on the bank in the amount of \$75.00, payable to a bank director for the purchase of three tickets to a fund raiser for the congressional campaign of a Mr. Flipppo. This also appears to be a violation of 2 U.S.C. 441b(a).

During the course of a recent examination of the First National Bank in Tuscumbia, Alabama, conducted in August of 1978, National Bank Examiner Dale Wilson discovered facts which this Office believes may constitute violations of the Federal Election Campaign Act. A description of these facts is contained below and this matter is referred to you for whatever action you deem appropriate.

Examiner Wilson discovered that the Vice President of the bank, William F. Gardiner, was contributing his services to the election campaign of Mr. Heflin, a United States Senatorial candidate, while Mr. Gardiner was in a salaried status at the First National Bank in Tuscumbia, (Tuscumbia). The exact period of his services is not known, however, the time period of Gardiner's services to Mr. Heflin's campaign exceeded the one-month period of Examiner Wilson's examination. Examiner Wilson was able to verify that Gardiner was not on vacation, nor was he in a leave status while donating his services to Mr. Heflin's campaign. When Examiner Wilson discussed this with officials of the bank, they did not consider anything improper with it and, in fact, thought it would help them in the future if Mr. Heflin were elected. Subsequently, these officials claimed that Gardiner, by donating his services to Mr. Heflin's campaign, was working on public relations on behalf of the bank.

These facts appear to constitute a violation of the Federal Election Campaign Act, specifically, 2 U.S.C. 441b(2), as further clarified and defined by 18 U.S.C. 591(e)(1) and (4).

Additionally, Examiner Wilson discovered an expense check, dated January 11, 1978, payable to Director Beasley in the amount of \$75.00 for three tickets to a campaign fund-raising dinner for Mr. Flipppo, a U. S. Congressional candidate. The voucher containing evidence of this expense check can be found at the Tuscumbia bank.
