I, Laura E. Sinram, recording secretary of the Federal Election Commission executive session, do hereby certify that on June 22, 2017, the Commission took the following actions in

the above-captioned matter:

1. Failed by a vote of 2-3 to:
 - a. Open a MUR.
 - b. Find reason to believe that Council of Insurance Agents & Brokers PAC, and Ken A. Crerar acting in his official capacity as treasurer violated 52 U.S.C. § 30104(b)(3) and (4).
 - c. Find reason to believe that Council of Insurance Agents & Brokers PAC, and Ken A. Crerar acting in his official capacity as treasurer violated 52 U.S.C. § 30102(a), and direct the Office of General Counsel to amend the proposed conciliation agreement and Factual and Legal Analysis accordingly.
 - d. Enter into pre-probable cause conciliation with Council of Insurance Agents & Brokers PAC, and Ken A. Crerar acting in his official capacity as treasurer, prior to a finding of probable cause.
 - e. Approve the appropriate Factual and Legal Analysis, as recommended in the First General Counsel's Report dated May 23, 2017 subject to the proposed amendment made by Commissioner Weintraub at the table.

- f. Approve the conciliation agreement, as recommended in the First General Counsel's Report dated May 23, 2017 subject to the proposed amendment made by Commissioner Weintraub at the table.
- g. Approve the appropriate letters

Commissioners Goodman, Hunter, and Petersen dissented.
