Dear Mr. Jordan:

On behalf of my clients, Friends of Charlie Wilson and Angela Hatfield, Treasurer ("Respondents"), I write to respond to the Complaint in MUR 6647.

The Complaint involves contributions Respondents lawfully accepted, and a loan that the candidate lawfully made more than six years ago. The Complaint claims that Respondents received an excessive contribution from a union PAC, even though a review of their reports would have shown that there was no excessive contribution. The Complaint alleges further that Respondents failed to disclose whether the loan was from the candidate's personal funds, even though earlier reports showed clearly that it was. Respondents have taken the necessary steps to clarify these matters, and no further Commission action is warranted.

DISCUSSION

Friends of Charlie Wilson is the principal campaign committee of Charlie Wilson, a candidate for Congress in Ohio's Sixth District; Angela Hatfield is its treasurer. The Committee registered with the Commission in 2005 and served as Mr. Wilson's principal campaign committee in subsequent elections, including the 2012 election. On April 18, 2006, Mr. Wilson loaned \$250,000 to his 2006 primary election campaign for Congress. The report at that time clearly showed that the loan was made with his personal funds. See Exhibit A.

During his 2012 campaign, on February 16, 2012, Respondents received a \$5,000 contribution for the primary election from the Sheet Metal Workers' International Association Political Action League. On February 18, 2012, it filed a 48-hour report disclosing this contribution. *See* Exhibit B. Respondents later learned of two online contributions received on February 16, 2012. Accordingly, they filed an amended 48-hour report, adding these newly-discovered contributions to the one received that same day from the Sheet Metal Workers PAC. *See* Exhibit C. However, the report did not indicate that it was an amendment.

Thus, while the transaction ID number for the Sheet Metal Workers PAC's contribution – C6883451 – was the same on both 48-hour reports, and again on the April 15 Quarterly Report, *see* Exhibit D, a cursory reader might have thought that the Sheet Metal Workers PAC had made two contributions, not one.¹ This is exactly what the Complaint did. It argued either that Respondents overreported the Sheet Metal Workers PAC contribution by disclosing it twice on their 48-hour reports, or that they received an excessive contribution. *See* Complaint at 3. It then proceeded to speculate that Respondents refunded the "excessive" contribution and failed to disclose the "refund." *See id.* at 4.

In its zeal to trigger Commission process against Mr. Wilson's campaign, the Complaint pointed also to the disclosure of the 2006 loan on Respondents' April 15 Quarterly Report. They claimed that, because the loan did not contain the notation "Personal Funds" on Schedule C, Respondents had somehow failed to disclose its source – even though the loan was more than six years old, and even though the candidate's use of personal funds to make the loan had long been a matter of public record. *See* Exhibit A.

Even if the Complaint could be taken to allege a violation by Respondents, it would warrant no further action. Respondents have taken the necessary steps to clarify the public record. They filed an amended April 15 Quarterly Report to make clear that the 2006 loan was made with the candidate's personal funds. *See* Exhibit E. They responded to a Commission Request for Additional Information about the Sheet Metal Workers PAC contribution and the 2006 loan, which correctly surmised that they "may have filed duplicate 48-hour notices." They explained that the 48-hour report filed on February 24, 2012, should have been marked as an amendment. Finally, they have taken steps, in consultation with their external campaign finance reporting vendor, to ensure that late contributions are properly tracked, and that their reporting software generates the necessary text for items like the 2006 loan.


¹ The Sheet Metal Workers PAC later made a \$5,000 contribution for the general election, which Respondents received on March 10.
