Re: Complaint of possible violation of by Jessica Puente Bradshaw, candidate for U.S. Congress, District 34 of Texas.

To Whom It May Concern,

Jessica Puente Bradshaw is a declared Republican candidate for U.S. Congress in the 34<sup>th</sup> District of Texas. The Republican Party of Texas website states that she filed for candidacy on December 16, 2011. (See <http://candidates.texasgop.org/candidates/jessica-puente-bradshaw>). Ms. Puente Bradshaw acknowledged this fact in a Facebook post on December 16, 2011 in which she states "GREAT NEWS! Today I filed my candidacy for United States Congress in District 34 under the Texas Legislature map. Thank you for the friends und individuals who helped make this happen! I look forward to a great campaign, with a great team. If you would like to join us please visit my website: <http://texansforjessica.com/>— with Jessica Puente Bradshaw and Steve Munisteri." (See <https://www.facebook.com/JessicaPBradshaw>).

However, as of April 18, 2012, there is no record of Jessica Puente Bradshaw filing FEC Forms 1 or 2 on [www.fec.gov](http://www.fec.gov). I believe this may be a violation of Federal Election Law, specifically 11 CFR 101.1(a); 102.1(a) and 102.2(a), which designate specific time periods by which a candidate and campaign committee must file their respective forms.

Ms. Puente Bradshaw has operated an active multi-county campaign since December which I believe constitutes "campaigning" as defined under Title 11 of the Code of Federal Regulations (11 CFR) 100.72(b) and 100.131(b) by:

- Taking action to qualify for the ballot;

- making and authorizing statements that refer to herself as a candidate for U.S. Congress;


