Subj: Reporting a possible violation of Federal Election Campaign Act by Sanje Sedera, Candidate for Nevada State Legislature District 34

I am a retired Federal Agent and was researching the internet for my wife Victoria Seaman who is running for Nevada State Legislature District 34, for opposition research on one of her Democrat opponent named Sanje Sedera. During my research I came across a recent news article that was posted on the web dated May 8, 2014 from Asian Tribune, Los Angeles, CA. by Daya Gamage - Asian Tribune US National Correspondent.

Facts:

In the web news article it purported that the Sri Lanka Consul General Malraj de Silva held a fundraiser for Sanje Sedera, Assembly Candidate for Nevada District 34 at his (Silva) residence in Los Angeles, Ca. The article openly reports that a foreign government representative held a fund raiser for a US naturalized citizen and admitted that the Sri Lanka government would be assisting Sedera by sending former Sri Lanka military personnel to travel to Las Vegas, Nevada in mid-May to campaign for Sedera in Nevada Assembly District 34. Additionally comments purported in the article by CG Silva that that the election of Sedera would send a Sri Lanka voice to a state legislative voice in the US and comments by Sedera addressing the gathering said that as much as he would be committed to his constituents if elected he will take all efforts to help Sri Lanka get her rightful place among lawmakers of Nevada and beyond.

Violation:

In reading the Federal Election Campaign Act (FECA) it states that it is a violation of the law in that FECA prohibits any foreign national from contributing, donating or spending funds in connection with any Federal, State or local election in the US either directly or indirectly. I believe based upon the evidence (news report) that Sedera has committed a violation of the FECA.

I have attached the supporting documents web article which purports that the election of Sedera would send a Sri Lanka voice to a state legislative voice in the US. Which raises the question of whose interest would Sedera be representing if he got elected those of NVs or those of Sri Lanka government.


