On June 27, 2014, Kaiser Foundation Hospitals, Kaiser Foundation Health Plan, Inc. and The Permanente Medical Group, Inc. received documents reflecting that Office and Professional Employees International Union, Local 29, AFL-CIO (Local 29) filed a complaint with the Federal Election Commission alleging the named respondents are "non-compliant with Chapter I, Part 114 Corporate and Labor Organization Activity, Section 114.5" by failing to honor employee request for voluntary payroll deductions.
