Response to Alleged Violation

Vickie Potts is the treasurer of Kreegel for Congress. She was solely and exclusively responsible for the filing of the October quarterly reports covering the months of July 2012-October 2012. Potts was aware of claims made by Revolvis and others on its behalf. Potts is aware however that said claims were disputed and otherwise categorically denied as due and owing.

Potts was unaware that 11 CFR 116.110 required that "disputed debts" be reported.

Immediately upon receipt of the FEC (MUR 6712) the matter was referred to legal counsel for review. Legal counsel informed Ms. Potts of the requirement for reporting disputed debts. Therefore, Ms. Potts immediately undertook to file an Amended FEC Financial Disclosure. Specifically, modifying line number 10, "other debts", to include \$52,262.63 as other debts that were disputed. This was accepted by FEC 848876 superseding FEC 816093. A copy attached as Exhibit A.

Potts is a lay person with no special skill or knowledge associated with FEC Regulations and serves in this capacity as a treasurer on a volunteer basis.

WHEREFORE, Respondents pray this matter be found as no violation of the act and close the file.
