This office represents Pridemore for Congress and its Treasurer Caleb Crosby in the above-captioned MUR. Enclosed please find a Statement of Designation of Counsel by our clients.

On December 2, 2013, Pridemore for Congress received your letter indicating that Pridemore for Congress and its Treasurer may have violated the Federal Election Campaign Act of 1971, as amended. The complaint enclosed with your letter is based on factual claims that will take longer than the 15-day allotted time to investigate and prepare an appropriate response. Though this office typically requests an additional 20 days to respond to a complaint, counsel will be away from the office for approximately two weeks during that 20-day period which coincides with year-end holiday schedules. Therefore, I respectfully request a 35-day extension, until January 21, 2014, to file a response on behalf of both clients.
