Re: Complaint Against 'All Citizens for Mississippi' and
unknown persons associated with the entity and
Citizens for Cochran, John Robinson, Treasurer

To Whom It May Concern:

On behalf of Tea Party Patriots Citizens Fund and its Chairman, Jenny Beth Martin (collectively, "TPPCF"), and pursuant to 2 U.S.C. § 437g(a)(1) and 11 C.F.R. § 111.4, the undersigned files this Complaint against 'All Citizens for Mississippi' and unknown persons associated with the entity and Citizens for Cochran, John Robinson, Treasurer (collectively "Respondents").

Tea Party Patriots Citizens Fund is an Independent Expenditures Only PAC registered with the Federal Election Commission, dedicated to electing true conservatives to the United States House and Senate who will help restore personal freedom, economic freedom, and a debt-free future to America. TPPCF has endorsed state Senator Chris McDaniel for the U.S. Senate in the June 3, 2014 Republican Primary in Mississippi, the first true challenge to incumbent GOP Senator Thad Cochran's (R-MS) automatic reelection.

Identity of Respondents.

The Mississippi Link is a newspaper published in Jackson, MS in both on-line and print editions. <http://themiississippilink.com/about-us/> "The Mississippi Link is an African-American owned newspaper and media company that emphasizes the concerns of the African-American community and its readers". In the edition of the newspaper denoted as Vol. 20, No. 31, May 29-June 4, 2014, a full-page ad in favor of Thad Cochran's re-election to the United States Senate appeared ("The Ad"). See Exhibit #1, Newspaper Ad in *Mississippi Link*.

The disclaimer on the Ad says it is 'Paid for by All Citizens for Mississippi'. See Exhibit #1.

The Ad's disclaimer does not meet the requirements under the regulations of the Federal Election Commission ("FEC") for disclaimers paid for by persons not authorized by the candidate and provides no permanent street address or website address for the entity "All Citizens for Mississippi".

A review of the FEC website reflects no federal political committee filed of record with the FEC under the name "All Citizens for Mississippi". See Exhibit #2, Screenshot of FEC Candidate and Committee Viewer webpage.

Further, there is no report of independent expenditures disclosing the costs of the Ad, which undoubtedly cost at least \$1,000 and, therefore, as a communication expressly advocating the re-election of Thad Cochran, triggers the filing of an independent expenditure report with the FEC. A review of the FEC 24-hour independent expenditures reports reflects no filing by an entity known as "All Citizens for Mississippi". See Exhibit #3, Report of 24-hour filings of Independent Expenditures in the last seven (7) days between Sunday, May 25 and Saturday, May 31, 2014 by an entity known as "All Citizens for Mississippi".

Finally, the photograph in the Ad is the official campaign photograph that appears on the biography page of the Cochran for Senate website. See Exhibit #4, Biography page of Cochran for Senate website, located at <http://thadformississippi.com/biography/>. As such, the Ad republishes candidate / campaign materials in violation of FEC regulations.

Applicable Law.

Violation #1: The Ad does not contain a proper disclaimer and identifying information as to the source of the Ad.

Federal law requires persons making communications about federal candidates to disclose their identity in a manner consistent with the FEC regulations. 11 C.F.R. §110.11. The Ad violates several provisions of law by not disclosing the identity of the source of the Ad.

FEC regulations require:

"(3) If the communication...is not authorized by a candidate, authorized committee of a candidate, or an agent of either of the foregoing, the disclaimer must clearly state the full name and permanent street address,

telephone number, or World Wide Web address of the person who paid for the communication, and that the communication is not authorized by any candidate or candidate's committee." 11 C.F.R. §110.11(b)(3).

If the Ad *was* authorized by Cochran for Senate, that should also be stated in the Ad. ("If the communication...is authorized by a candidate, an authorized committee of a candidate, or an agent of either of the foregoing, but is paid for by any other person, the disclaimer must clearly state that the communication is paid for by such other person and is authorized by such candidate, authorized committee, or agent;") 11 C.F.R. §110.11(b)(2).

Here, the Ad does not indicate whether it is authorized – or not authorized; nor does it provide the identifying information as to the source of the Ad, which information is required by federal law.

If the source of the funding for the Ad is not a registered federal political committee – and according to the FEC database, 'All Citizens for Mississippi' is not a registered federal political committee of any kind – then it is illegal for the expenditure for the Ad to be coordinated with or authorized by Cochran for Senate (11 C.F.R. §109.21) or for any agent of Cochran for Senate to be involved in the solicitation or expenditure of funds not subject to the limits and prohibitions of the Federal Election Campaign Act of 1971, as amended. 2 U.S.C. §441i(e) and 11 C.F.R. §300.52.

Further, a public communication that expressly advocates the election or defeat of a clearly identified federal candidate must comply with the disclaimer requirements applicable to federal registered political committees. 11 C.F.R. §110(a)(2).

Violation #2: There is no independent expenditure report filed of record within 24-hours of distribution of the Ad.

The Mississippi primary election is on June 3, 2014. All independent expenditures made within twenty days of an election in amounts of \$1,000 or more must be reported to the FEC within 24-hours of public dissemination. 11 C.F.R. §109.10(d). The report must reveal the name and address of the person paying for the communication, the type of communication, the amount paid, the date disseminated and the candidate supported or opposed in the communication. *NONE* of that information has been made available to the public by 'All Citizens for Mississippi' and there is speculation as to who is responsible for having paid for the Ad. See Exhibit #5, "Jackson Jambalaya: Ad Seeks Democratic Votes for a Republican Primary" ("The Ad says at the bottom of the page it is paid for by "All Citizens for Mississippi". The organization is not listed in the Secretary of State's website...") <http://kingfish1935.blogspot.com/2014/05/ad-seeks-democratic-votes-for.html>

The Ad invites Democrats to vote in the Republican primary on Tuesday to reward Senator Thad Cochran for his largesse in using taxpayer dollars to reap political favors at election time. See the Ad, which outlines various federal funds Sen. Cochran ostensibly directed toward the African-American community during his 41-year tenure as Senator and, most particularly, his years as a member of the Senate Appropriations Committee. See Exhibit #1.

The purpose of the disclaimer and reporting requirements of federal law is to ensure that the voting public is aware of who is funding public communications advocating the election or defeat of federal candidates. The Ad's sponsors have deliberately failed to comply with the disclosure and reporting requirements in an effort to hide their identity. Such misconduct cannot go unpunished.

Violation #3: Use and republication of candidate / campaign materials by a third party constitutes per se coordination; the Ad is, therefore, an illegal in-kind contribution to the Cochran for Senate campaign.

Federal law is quite clear on this point: *any* "financing of the dissemination, distribution, or republication, in whole or in part, of any broadcast or any written, graphic, or other form of campaign materials prepared by the candidate, the candidate's authorized committee, or an agent of either of the foregoing shall be considered a contribution for purposes of contribution limitations and reporting responsibilities of the person making the expenditure." 11 C.F.R. §109.23

The question then arises as to what type of entity is "All Citizens for Mississippi". If it is a prohibited source, *e.g.*, a corporation, labor union, national bank or foreign national without permanent resident status in the United States, that gives rise to an additional violation of federal law. Additional questions as to whether the candidate, Thad Cochran, or Cochran for Senate or any agent thereof played any role in the development, placement and payment of the Ad. Such conduct would constitute further illegal coordination between 'All Citizens for Mississippi' and Cochran for Senate and must be fully investigated.

Conclusion.

Upon information and belief, and based upon the facts set forth above, Respondents 'All Citizens for Mississippi' and unknown persons associated with the entity and Citizens for Cochran, John Robinson, Treasurer have, each of them, individually and collectively, violated the Federal Election Campaign Act of 1971, as amended and must be held accountable and liable for their unlawful actions.

Renowned author Maya Angelou dies at 86

Maya Angelou's story averted millions. A black woman born poor, wrote and related the most popular presidential inaugural poem in history.

A childhood victim of rape, shared into silence, eventually told her story through one of the most widely read memoirs of the past few decades.

Angelou, a Renaissance woman and cultural pioneer, died Wednesday morning, May 28, 2014 at her home in Winston-Salem, N.C. Her son, Guy B. Johnson, issued the statement announcing her death.

Born April 4, 1928, the 86-year-old had been a professor of American studies at Wake Forest University since 1982.

"She lived a life as a teacher, activist, artist and human being. She was a warrior for equality, tolerance and peace," Johnson said.

Angelou had been set to appear this week at the Major League Baseball Inaugural Luncheon, but she canceled to recover from an unspecified illness.

Tall and regal, with a deep, majestic voice, she was unforgettable whether encountered through sight, sound or the printed word.

She was an actress, singer and dancer in the 1950s and 1960s and broke through as an author in 1970 with "I Know Why the Caged Bird Sings," which became a standard (and occasionally censored) reading and made Angelou one of the first black wom-

en to enjoy mainstream success.

The world was watching in 1993 when she read her emotionally hopeful poem "On the Pulse of Morning" at President Bill Clinton's first inauguration. Her confident performance openly delighted Clinton and made publishing history by making a poem a best-seller, if not a critical favorite.

For President George W. Bush, she read another poem, "Amazing Peace," at the 2005 Christmas tree lighting ceremony at the White House.

Presidents honored her in return with a National Medal of Arts and the Presidential Medal of Freedom, the ceremony's highest civilian honor. In 2013, she received an honorary National Book Award.

She was a mentor to Oprah Winfrey, whom she befriended when Winfrey was still a local

television reporter, and often appeared on her friend's talk show program.

She mastered several languages and published not just poetry, but advice books, cookbooks and children's stories.

She wrote music, plays and screenplays, received an Emmy nomination for her acting in "Roots," and never lost her passion for dance, the art she considered closest to poetry.

"The line of the dancer: if you watch (Michelle) Obama and you see that line, that's what the poet tries for. The poet tries for the line, the balance," she told *The Associated Press* in 2008, shortly before her 80th birthday.

Her very name as an adult was

Lewis utilized the chickens that his parents required he take care of to insure they laid eggs and hatched as examples for the graduates. He stated that some of the chickens "looked at him attentively," while some "pretended" to be paying attention, and

NAACP Jackson branch awards those keeping with its principles and traditions

The Jackson Branch NAACP handed out awards Saturday, May 24, 2014 to people whose work has been in keeping with the traditions and principles set forth by past leaders of the association.

The keynote speaker at the 88th annual Freedom Fund Awards Banquet, held at the M.W. Stringer Grand Lodge in West Jackson, was Rev. Dr. Isaac Jackson, president of the General Missionary Baptist State Convention of Mississippi, Inc. and pastor of Liberty Missionary Church in Canton. He spoke on the banquet theme, "All In For Justice & Equality."

Greater Blair Street AME Zion Church received the Madge Evers Award, named after the slain NAACP field secretary.

The Dr. Aaron Henry Award went to Lolita Bolden. Henry was president of the Mississippi NAACP for 33 years.

The Boys and Girls Club of The Capitol Area was recognized with the John D. Hope Award. Mary Gerner received the De-

lore Orey Lifetime Service Award for her service to the organization. She is currently the assistant secretary for the Jackson Branch.

Certificates of appreciation were given to sponsors of the event.

Jackson, speaking in ministerial tone while delivering a message of social conscience, touched on issues the NAACP has addressed throughout its history and others that have developed in recent decades.

The NAACP has faced adversity from the beginning and continues to do so. Jackson referenced the movie character Forrest Gump who when confronted by bullies ran so fast that he ran out of his crutches, then learning to walk freely.

"Adversity is good for you. It will make you leave your crutches behind," Jackson said. "And

where all you've known is adversity all your life, what's your more challenge? Bring it on," he said.

Jackson urged the crowd not to be afraid to speak out and fight for things that benefit them. He also talked about his support of unions, something the NAACP Jackson Branch has been pushing for at the Nissan plant in Canton. Jackson, who laughs in the

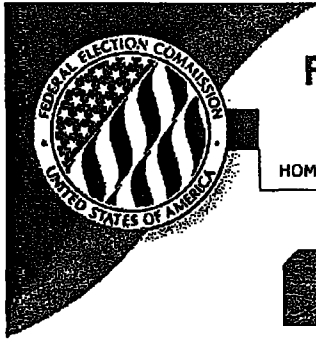

The son of career educators, Thad Cochran was born in Pontotoc, Mississippi. Throughout his early school career, Thad enjoyed great success. When the Cochran family moved to the Byram community of Hinds County near Jackson, there was much time devoted to sports, music, the Boy Scouts, and church activities. Thad became an Eagle Scout and helped establish a new scout troop at Spring Ridge Methodist Church. He served as its first Junior Assistant Scout Master.

At Byram High School, Cochran earned varsity letters in football, basketball, baseball, and tennis. He gave a piano and voice recital his senior year and was class valedictorian. He was also a member

of the 4-H Club and Daniel Memorial Baptist Church.

Cochran earned a B.A. degree at the University of Mississippi with a major in psychology and a minor in political science. He was elected president of his social fraternity, Pi Kappa Alpha, was a company commander in the Navy ROTC, student body vice president, and was selected for membership in Omicron Delta Kappa, a national honorary leadership fraternity.

When he graduated from Ole Miss, Cochran was commissioned an Ensign in the U.S. Naval Reserve and assigned to duty aboard the USS MACON, and served on the ship for 18 months becoming the ship's legal officer after graduating as an honor student from the U.S. Navy School of Justice in Newport, Rhode Island. He also became qualified as Officer of the Deck, in port and underway. When his ship was decommissioned, Cochran was assigned to the staff of the Commandant of the Eighth Naval District in New Orleans, Louisiana, to complete his two-year tour of active duty in the Navy.

Cochran then enrolled in the School of Law at the University of Mississippi, where he won the Frederick Hamel Memorial Award for having the highest scholastic average in the first year class. He was selected for membership in the honorary legal fraternity Phi Delta Phi, served on the editorial board of the Mississippi Law Journal, argued before the Mississippi Supreme Court as a moot court finalist, and was elected chairman of the Honor Council.

Before graduating from law school, Cochran was awarded a Rotary Foundation Graduate Fellowship and studied jurisprudence and international law for a year at Trinity College, University of Dublin, Ireland. During this year abroad, he spoke to numerous Rotary Clubs and other groups in Ireland on the subject of the civil rights struggle in Mississippi and the United States. He also won the Hillary Term Moot Court competition sponsored by the Dublin Law Society.

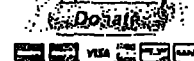


