Further, I have never as an Individual used Twitter, as any Tweets associated with my Candidacy were posted by my Web Consultant and Web Compliance Mgr, (Craig Agranoff, craig@PoliticalConsulting.com, TN:), or a Member of his Staff. Individual Flyers sent out on Twitter also had Disclosure Statements and they were designed and sent out via Twitter by my Campaign Consultant, Margie Helsehein, TN:

I was assured by Mr. Agranoff that all correspondence was properly coded and complied with existing FEC rules regarding communications with the public.

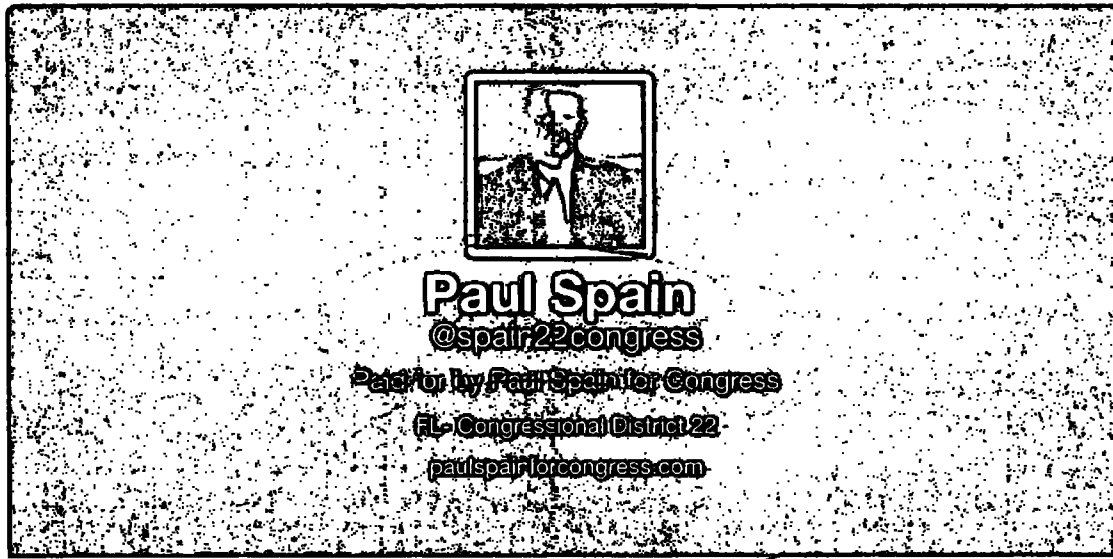
Regarding Mr. Shamis and his Complaint. It appears from newspapers that Mr. Shamis was the Marijuana Candidate who was allowed to be on the ballot after complaining to the State of FL Elections Board that he should not be denied access to the Ballot and Voters just because he could not afford the \$10,000. Filing Fee. He was subsequently allowed to be a Write-In Candidate on the 2014 Congressional Ballot. 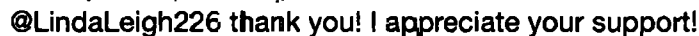
