Re: Complaint Against Committee to Elect Harry Reid Before The Federal Election Commission

Dear Ms. Stevenson and/or the Office of the General Counsel:

I hereby file this complaint seeking an immediate investigation into the failure of United States Senator Harry Reid (D-NV) to use a proper disclaimer when soliciting funds for a non-federal office seeker, Lucy Flores. Lucy Flores is a Democrat candidate for lieutenant governor in the state of Nevada. The Committee to Elect Harry Reid ("Harry Reid") failed to clearly state they were not soliciting corporate contributions. Nevada law allows state candidates to accept corporate contributions. Therefore, Harry Reid clearly violated Federal Election law in an email fundraising solicitation which deliberately left out a proper disclaimer which would have expressly mentioned the strict law against federal office holders requesting money from corporate contributors.

The Committee to Elect Harry Reid has an absolute and obvious duty to disclose that they cannot solicit corporate contributions. Harry Reid knowingly violated Federal Election Law, specifically, [11 CFR 300.64(b)(2)(i)] which states that "A Federal candidate or officeholder may limit such a solicitation by displaying at the fundraising event a clear and conspicuous written notice, or making a clear and conspicuous oral statement, that the solicitation is not for Levin funds (when applicable), does not seek funds in excess of \$[Federally permissible amount], and does not seek funds from corporations, labor organizations, national banks, federal government contractors, or foreign nationals." Yet, Harry Reid failed to comply with this mandated regulation in its email solicitation for Lucy Flores. A copy of the email is enclosed herewith as is the donation page it is linked to.

For these reasons, I respectfully request that your commission conduct an immediate investigation into Harry Reid and the Committee to Elect Harry Reid's failure to comply with this important federal regulation, and impose any and all penalties allowed or deemed appropriate by this commission. The facts outlined herein are from public sources and general public knowledge. Thank you.



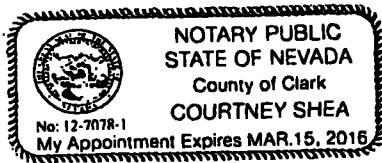

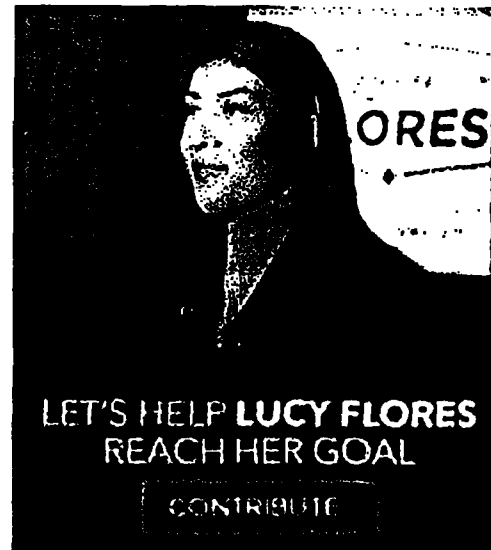


Friend --
