Dear Mr. Jordan:

This letter is submitted in response to the complaint filed in MUR 7117. The complaint is based on the fact that the July Quarterly report of Joe Garcia for Congress, the principal campaign committee of candidate Joe Garcia, was filed on July 16, 2016, rather than on July 15. Despite the Committee's correction of any filing issue within hours of the deadline, Complainant nevertheless makes sweeping allegations that the Committee purposely flaunted the law and was unwilling to comply with it.

In reality, the Committee transmitted its Quarterly report electronically to the FEC for filing on July 15, 2016. However, inadvertently, the report was erroneously designated as a Q1 April Quarterly Report. Due to that error, the Committee received an immediate reply email from the FEC dated July 15, 2016 informing it that processing was not possible "...because an incorrect ending coverage date of 6/30/2016 was used...." (See Attachment 1.) The Committee acted immediately to correct the error by checking the appropriate box for the July Quarterly Report and transmitting the report for filing with the FEC. The Committee received a response that the Form was "successfully transmitted," and therefore believed the July Quarterly was timely filed and on the public record as of July 15. (See Attachment 2 consisting of a copy of a screen shot generated by NGP, which is an FEC approved vendor.)

However, on July 16, the Committee realized that its report had indeed not appeared on the public record. The Committee immediately began making attempts to file the report, but these were rejected several times. The Committee retained some of screen shots of its repeated attempts to file the report. (See Attachment 3. Note that the committee also received additional screen shots matching that in Attachment 2.) Finally, the filing was accepted. (Note that the Committee filed a Form 99 explaining the problems it encountered regarding its July Quarterly Report.)

Respondent believes that the situation demonstrates that it used best efforts to file in a timely manner. (See 11 C.F.R. § 111.35(b)(3)). The Committee indeed assumed that its report was filed when it received a message indicating filing was "successfully transmitted," and reasonably relied on that notification as indication that its report was available on the public record. Upon discovering that its July Quarterly report had not been transmitted, Respondent immediately took steps to correct the situation and filed within 24 hours of the filing deadline. (See 11 C.F.R. § 111.35(b)(3)(ii)). Further, Respondent has timely filed all other FEC reports in this cycle.

The above outlined factual record demonstrates that Respondent: 1) intended to file on time; 2) attempted to file on time; 3) immediately addressed the situation when it realized the report was not on the public record; and 4) corrected the situation by filing within 24 hours of the due date. Further, the Committee has instituted new procedures to ensure future timely filing, to include avoiding reliance on a vendor transmission message and considering a report to be filed only when it receives the "FEC Financial Disclosure Filing Acknowledgement" email from the FEC acknowledging the receipt and acceptance of its electronic filing via the DISCLOSE protocol.

Given the minimal delay in filing and the Committee's attempt to take immediate corrective action, we respectfully request that the Commission dismiss this complaint and take no action in this matter. Once again, the Committee will take all necessary steps and institute corrective measures to avoid late filing in the future.
