Re: Request for Investigation of Thomas P. Murphy, Jr. and Leslie Murphy for Multiple Violations of 52 U.S.C. § 30122 and 11 C.F.R. § 110.4(b)

Dear Mr. Petalas:

Pursuant to 52 U.S.C. § 30109(a)(1), I hereby request that the Federal Election Commission initiate an investigation of Thomas P. Murphy, Jr. and Leslie Murphy for multiple violations of 52 U.S.C. § 30122 and 11 C.F.R. § 110.4(b).

Thomas P. Murphy, Jr. and Leslie Murphy are the parents of Representative Patrick Murphy (D-FL). In 2013, Mr. and Mrs. Murphy participated in a donor swapping scheme with the parents of two other candidates for the House of Representatives to evade the individual contribution limits of the Federal Election Campaign Act ("FECA"), 52 U.S.C. § 30116(a)(1)(A), by reimbursing each other for contributions made to their respective children. *See generally* Chris Palmer and Jonathan Tamari, Candidates' parents' mutual donations, *Phil. Inquirer* (May 14, 2014) http://articles.philly.com/2014-05-14/news/49823785_1_campaign-finance-parents-contributions (last accessed November 17, 2015).

FECA prohibits a person from making a contribution in the name of another person. 52 U.S.C. § 30122 and 11 C.F.R. 110.4(b)(1)(i). The statute also prohibits a person from knowingly permitting their name from being used to effect a contribution in the name of another. 52 U.S.C. § 30122 and 11 C.F.R. § 110.4(b)(1)(ii). A contribution in the name of another occurs "whether accomplished through the advancement or reimbursement of funds." *U.S. v. O'Donnell*, 608 F.3d 546, 551 (9th Cir. 2010), *cert. denied*, 131 S. Ct. 1837, 179 L. Ed. 2d 794 (2011).

On March 16, 2013, Thomas P. Murphy, Jr. and Leslie Murphy each contributed \$5,200 to Patrick Murphy – the maximum legal contribution they could make to their son for the entire 2013-2014 election cycle. Friends of Patrick Murphy, April 15th Quarterly Report at 52-53 & 55 (April 15, 2013)(attached as Exhibit A). On June 22, 2013, Robert Strouse, the father of candidate Kevin Strouse, made a contribution of \$5,200 to Patrick Murphy. Friends of Patrick Murphy, July 15th Quarterly Report at 77 (July 15, 2013)(attached as Exhibit B). Four days later, Thomas P. Murphy, Jr. reimbursed Robert Strouse for that contribution by making an identical contribution of \$5,200 to the congressional campaign of Robert Strouse's son, Kevin Strouse. Kevin Strouse for Congress, July 15th Quarterly Report at 49 (July 15, 2013)(attached as Exhibit C). By reimbursing Robert Strouse for his contribution to Friends of Patrick Murphy, Thomas P.



Murphy, Jr. violated 52 U.S.C. § 30122 and 11 C.F.R. § 110.4(b) by making a contribution in the name of another.

Similarly, on February 19, 2013, Babulal Bera contributed \$5,200 to the campaign committee of his son, Ami Bera – the maximum contribution he could make for the 2013-2014 election cycle. Bera for Congress, April 15th Quarterly Report at 13 (July 15, 2013)(attached as Exhibit D). On March 5, 2013, Leslie Murphy made a contribution of \$5,200 to Ami Bera. Exhibit D at 87. Two weeks later, Babulal Bera reimbursed Leslie Murphy for that contribution by making an identical contribution of \$5,200 to the congressional campaign of Leslie Murphy's son, Patrick Murphy. Exhibit A at 11. By permitting her name to be used to make a contribution in the name of another, Leslie Murphy violated 52 U.S.C. § 30122 and 11 C.F.R. § 110.4(b).

Accordingly, I hereby request that the Federal Election Commission initiate an investigation of Thomas P. Murphy, Jr. and Leslie Murphy for multiple violations of 52 U.S.C. § 30122 and 11 C.F.R. § 110.4(b), impose appropriate sanctions and take any further action that may be appropriate.


