



**CONSENT TO EXTEND THE TIME TO INSTITUTE A CIVIL  
LAW ENFORCEMENT ACTION**

As consideration for the Federal Election Commission's ("Commission's") agreement to extend the period for responding to the General Counsel's Brief dated May 4, 2004, to June 10, 2004, Respondents Federer for Congress Committee and Thomas M. Busken, as Treasurer, hereby consent to toll the statute of limitations of any civil enforcement action that the Commission might institute in connection with MURs 5112 and 5383 pursuant to 2 U.S.C. § 437g(a)(6) for a period of forty (40) calendar days. This agreement, together with Respondents' prior statute of limitations tolling agreement dated September 22, 2003, will extend the expiration date of the five-year statute of limitations found at 28 U.S.C. § 2462, or any other statute of limitations or repose that may be applicable in this matter, for a total period of sixty (60) days. There shall be no additional consent to extend the time to institute a civil law enforcement action without the written consent of the Respondents or their representative.
