Dear Sirs;

I am in receipt of Ms. Sealander's reply to my complaint regarding the criminal violations of campaign contribution laws reported by Common Cause, and broadcast on C-Span. I find her response very troublesome (and at the same time, very revealing) due to the following inconsistencies in the aforementioned reply;


1. It is stated that my complaint was received on 10/28/96, which is a LIE- as demonstrated on the copy of the return receipt signed by your office, said complaint was received on 10/25/96.
2. It is also stated in this reply that the video referenced in my complaint had not been received as of 11/1/96. This is most disturbing, since as shown on the enclosed receipt from C-Span, this video was sent to Lee Ann Elliott via PRIORITY MAIL ON 10/21/96. It goes without saying that I will send a copy of your letter to C-Span and have them put a tracer on this package; should it be revealed that said video was INDEED obtained by your commission, a most disturbing collusion to suppress this evidence from the American people by the very parties which control your commission will be quite evident, and will, of course, be investigated.
3. Although your response was dated 11/1/96, it was not mailed until 11/4/96, as shown on the postmark of the envelope in which your reply was mailed. These delays are MOST disturbing, as had the immediate investigation which was warranted based on the serious nature of the charges made by Common Cause been conducted and publicized before the election, the American people too busy working to keep their heads above water would have been forced to see the corruption in the system which is enabled to go on via collusion of the very overseers put in place to prevent


such corruption; THE SAME DISEASE WHICH HAS MADE A MOCKERY OF THE "JUSTICE" SYSTEM IN THIS COUNTRY. 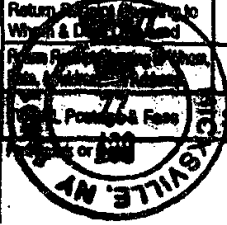

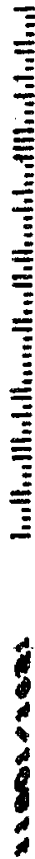
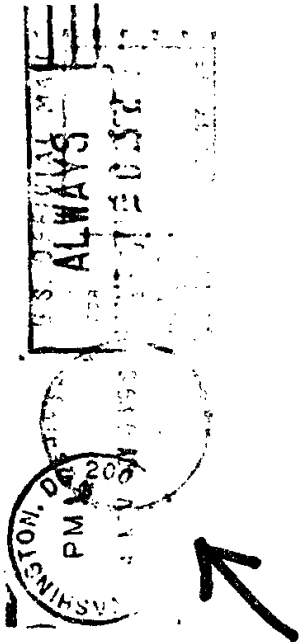
