# Chairez confident donation charges will be proved false

Former District Judge Don Chairez is awash in paperwork this weekend as he struggles to prove that he didn't violate Federal Election Commission laws by accepting illegal donations as the GOP's choice for Congress.

While addressing this complaint, he learned he may owe the secretary of state's office \$5,000 for failing to say what he did with nearly \$35,000 in leftover judicial campaign funds from 1996.

As a result of the complaint filed by John "Trey" Delap III, some of his big money donors are getting some tough-talking letters from the FEC, demanding they explain whether they made illegal contributions to him.

The FEC has not launched a formal investigation. But it has fired off letters to a number of Chairez's donors — including three top-level Mirage Resorts Inc. executives, the Imperial Palace's Ralph Englestad, Santa Fe's Paul Lowden and two GOP assemblywomen — that state: "You have the opportunity to demonstrate in writing that no action should be taken against you."

Delap, a former campaign fund-raiser for Democrat Shelley Berkley, who narrowly defeated Chairez in the Nov. 3 general election, on Nov. 9 asked the FEC to investigate whether Chairez accepted illegal donations.

Chairez on Friday was poring over his campaign finances to respond to the complaint, when he learned from the *Review-Journal* that the secretary of state's office had said he failed to meet a July deadline to file a report on his unspent contributions from 1996. The penalty for not filing is a \$100-a-day fine that would total more than \$15,000, except the law has a \$5,000 cap.

Chairez said he thought he had until sometime in January to file the report on unspent contributions.

When Chairez ran for district judge in 1996, he spent nearly \$26,000 but had \$34,614 left over in unspent contributions. The secretary of state's office said he should have filed the form explaining what he did with that nearly \$35,000 by July 15, since he had resigned in May to run for the 1st Congressional District seat in Las Vegas.

"I'm just a law-abiding citizen," Chairez said. "Did I wilfully fail

Corporate donations to federal candidates are banned, but businesses are allowed to contribute to Nevada candidates. The assemblywomen cannot donate from their campaign committee money because it might be corporate money.

Delap's complaint questioned how Chairez could collect checks for both the primary and the general after the primary, when Chairez reported that he had no debt.

FEC rules allow for primary contributions after the primary only to retire debt incurred during the primary. But in his

primary report, Chairez said he had no debt.

Now he is saying that some of the money he owed for the primary was late in being reported to the campaign.

Delap contended there are \$27,000 in questionable donations and wrote in his complaint that "I can't believe a former judge would show such reckless disregard for federal law."

Mirage Resorts executives Bobby Baldwin, Marc Schorr and William McBeath each wrote checks for the maximum amounts allowed — \$1,000 for the primary and \$1,000 for the general — in mid-October after the September primary.

Mirage spokesman Alan Feldman said the three are responding to the FEC letters and likely will explain that they wouldn't have known whether Chairez had debt.

Contributors frequently wait until after a primary and then give donations for both the primary and general elections. If Chairez has shown a campaign debt on his finance reports, there would have been no problems with raising the money after the primary, according to FEC regulations.

Two political action committees — including Newt Gingrich's Monday Morning — is suspected of having donated too much money. Gingrich gave the maximum of \$5,000 for both the primary and the general after the primary.

Santa Fe Gaming Corp. Chairman Lowden got one of the FEC letters claiming he gave \$3,000. His attorney is sending the FEC checks showing that Lowden gave \$2,000 and his wife, Sue, gave \$1,000 to demonstrate that he did not violate the rules.

Chairez's former campaign manager, Robert Spretnak, said he has gotten two calls and one letter from donors. "Only one asked for her contribution to be returned, and Don will respond to her that we are fighting this complaint."

"There was only one contribution we should not have taken, that was from the Henderson Police Officers Association. They're not qualified to contribute to a federal campaign," he said. The association is not a registered federal political action committee.

Spretnak said neither he nor treasurer Cynthia White had previous experience with the FEC laws.




