This letter is to respond to the complaint filed with the Federal Election Commission in which it is alleged that Judi Parker may have violated the Federal Election Campaign Act of 1971.

History:

I, Judi Parker did file for Congress in the 2nd Congressional District in the State of Missouri on the first day of filing, 2006. Due to a serious illness in my family, I did unfile as a candidate for Congress and immediately filled as a candidate for Missouri State Representative. This occurred on the last day of filing, 2006.

The campaign did collect funds during the period of time that I, Judi Parker, was a candidate for Congress. Immediately, upon withdrawing my candidacy for Congress I spoke with individuals from both the Federal Election Commission office and the Missouri Ethics Commission to verify that the contributions from the Congressional campaign could be transferred to the State Representative campaign. Upon verification of the ability to transfer the funds, I mailed each contributor a "designation" form regarding their choice of designation for the monies they had donated. I felt comfortable with this action as it was the ethical and right thing to do, in my opinion, even if it was not required. It took several weeks to send out all of the forms and to begin to receive completed forms back from the contributors. \$1,185.00 was transferred to the campaign for State Representative on May 3, 2006 based upon the payment of all outstanding debts and the receipt of "designation" forms from contributors. The lag time in transferring the rest of the monies was due to the lack of return of the forms and the simple matter of giving each contributor time in which to respond.

Some contributors were dismayed to be asked to do so as the cost of mailing back and forth was diluting their contribution. I then took the liberty of chatting with the individuals who had not returned a form by telephone, email, or in person. Enclosed you will find a listing of all contributors and the mode by which we communicated. Enclosed is also a copy of a blank "designation" form and those which were returned to our campaign office. The final transfer of the monies was then made on June 30, 2006 at which time there had been communication with each contributor.

Please note that contributions received after the date of withdrawal of my candidacy for Congress were all simply returned to the donor; some monies were also returned to donors upon their request. A spread sheet of contributors, monies donated, the disposition of each donation and the mode of communication with each individual is enclosed.

Your committee's filing has been accepted as a valid termination as it meets the conditions set forth in 2 U.S.C. § 433(d) and Section 102.3 of the Commission's Regulations. Your committee is no longer required to file reports on a periodic basis. However, 2 U.S.C. § 432(d) and Sections 102.9(c) and 104.14(b)(3) of the Commission's Regulations require that you maintain your records and copies of reports for inspection for at least three (3) years. In addition, you may be required to respond to Commission requests for information regarding your committee's federal election activity and previously filed reports.

If your committee again becomes active in federal elections, it will be required to re-register with the Commission in accordance with the Federal Election Campaign Act and applicable Regulations. Your committee will be treated as a new entity by the Commission and should register as a new committee on FEC FORM 1, pursuant to 2 U.S.C. §§ 432(g) and 433(a).

Please be advised that at the August 8, 2006, meeting of the Missouri Ethics Commission, the complaint filed against you was considered.

From the facts presented, the Commission determined that the allegation that you failed to report contributions is unfounded. Per Section 130.011(12)(F) RSMo, a candidate may transfer funds from a federal committee. None of the contributions were over the \$325 contribution limit. The Commission voted to dismiss this case as the allegation was unsubstantiated.

Having received the complaint this morning, I am better able to understand the complaint filed against the Judi Parker for State Representative Committee, and explain the timing of the two transfers from the Judi Parker for Congress Committee to the Judi Parker for State Representative Committee. Before any action was taken I did speak with individuals in both the Federal Election Commission and the Missouri Ethics Commission to verify that the contributions from the Congressional campaign could be transferred to the State Representative campaign.

As soon as I had received "designation" forms from contributors, we did transfer an amount of dollars that conformed to the dollar amount of the received forms. I waited a good amount of time and some conversations in order to secure the return of all of the forms. Some individuals were dismayed to be asked to do so as the cost of mailing back and forth was diluting their contribution. I therefore took the liberty of chatting with these individuals when at a meeting with them, by telephoning or emailing them. I felt comfortable with the actions I had taken as they were not required but they were the ethical and right thing to do, in my opinion. The lag time, therefore, in transferring the remaining funds was simply a matter of giving each contributor time in which to respond.

I do have copies of all deposit slips and checks received and deposited. I would be happy to fax these copies also if you think it is necessary.

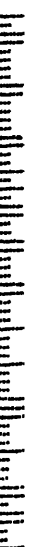

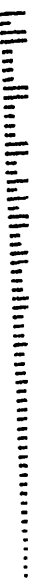
