

RE: Complaint against Mick Cornett for Congress (Oklahoma – District 5)

To Whom It May Concern:

Except for a few months following my graduation from the University of Oklahoma in 1958 I have lived in Oklahoma City all of my life. During all those years I have never before patronized any company offering such video services as that portrayed in Mayor Cornett's "advertisement." Yet, I received this promotional piece from his corporation less than 45 days before the primary election (see enclosed). I believe this to be an illegal corporate contribution done in coordination with the candidate. I am not an expert in federal election law but this does not even come close to passing the smell test. I believe this "advertising piece" to be actually a name-identification gimmick to support his campaign for U. S. Representative paid for with corporate funds.

Several years ago in Oklahoma, Governor David Walters utilized a company of his to funnel campaign contributions from others to illegally promote his campaign. He later pleaded guilty to a misdemeanor for such action. This appears to me to be the same sort of deal. I believe that this brochure was sent only to Republican voters in violation of the election laws. Please investigate this activity as soon as possible since the primary is July 25, 2006.






