COMPLAINT

Complainant files this complaint against the Santorum Victory Committee, Keith Davis, in his capacity as Treasurer; and the Republican Federal Committee of Pennsylvania; Santorum

II. ARGUMENT

A. Legal Background

11 C.F.R. § 110.11(b)(1) requires that public communications paid for and authorized by an authorized committee of a candidate include a disclaimer that "must clearly state that the communication has been paid for by the authorized political committee." 11 C.F.R.

§ 110.11(c)(2)(ii) further requires that for printed communications, the disclaimer "must be contained in a printed box set apart from the other contents of the communication."

11 C.F.R. § 102.17(a)(1)(i) requires that political committees that engage in joint fundraising "shall either establish a separate committee or select a participating committee, to act as fundraising representative for all participants."

11 C.F.R. § 102.17(c)(2)(i) requires that every solicitation for contributions from a joint fundraising committee include the following:

(A) The names of all committees participating in the joint fundraising activity whether or not such committees are political committees under 11 CFR 100.5; and

(B) The allocation formula to be used for distributing joint fundraising proceeds; and

(C) A statement informing contributors that, notwithstanding the stated allocation formula, they may designate their contributions for a particular participant or participants; and

(D) A statement informing contributors that the allocation formula may change if a contributor makes a contribution which would exceed the amount that contributor may give to any participant.

Furthermore, 11 C.F.R. § 102.17(c)(2)(ii)(B) requires, "If one or more participants can lawfully accept contributions that are prohibited under the Act, a statement informing contributors that contributions from prohibited sources will be distributed only to those participants that can accept them."

B. Application to Facts

1. Santorum 2006 Disclaimer

The Santorum 2006 invitation to the Simmons event was not contained in a printed box, in plain violation of 11 C.F.R. § 110.11(c)(2)(ii).

2. Santorum Victory Committee Disclaimer

The Santorum Victory Committee solicitation did not include the allocation formula for joint fundraising proceeds. It did not include a statement informing contributors that, notwithstanding the stated allocation formula, they may designate their contributions for a particular participant or participants. It did not include a statement informing contributors that the allocation formula may change if a contributor makes a contribution which would exceed the amount that contributor may give to any participant. And though one participant, the Republican Federal Committee of Pennsylvania, can lawfully accept funds prohibited under the Federal Election Campaign Act, the solicitation did not include a statement informing contributors that contributions from prohibited sources will be distributed only to those participants that can accept them. These are clear violations of the disclaimer requirements of 11 C.F.R. § 102.17.


3. Joint Fundraising Without a Joint Fundraising Committee

Both Santorum 2006 and the Republican Federal Committee of Pennsylvania sent invitations raising money for the event at the home of Hilarie and Mitchell Morgan on June 14, 2005. No joint fundraising committee was established, and neither committee was selected as fundraising representative. Instead, the Respondents conducted a joint fundraiser in clear violation of the joint fundraising requirements. There was therefore no public disclosure of how costs were allocated, and no way to ensure that each committee paid its fair share of the fundraising expenses. This activity was a blatant violation of the joint fundraising requirements at 11 C.F.R. § 102.17.


III. REQUESTED ACTION

As we have shown, Respondents have violated the Federal Election Campaign Act. Accordingly, we request that they be enjoined from further violations, be required to repay their illegal contributions and be fined the maximum amount permitted by law.

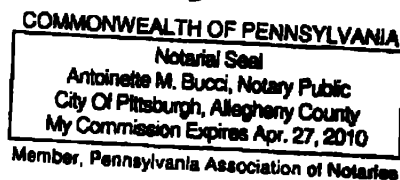

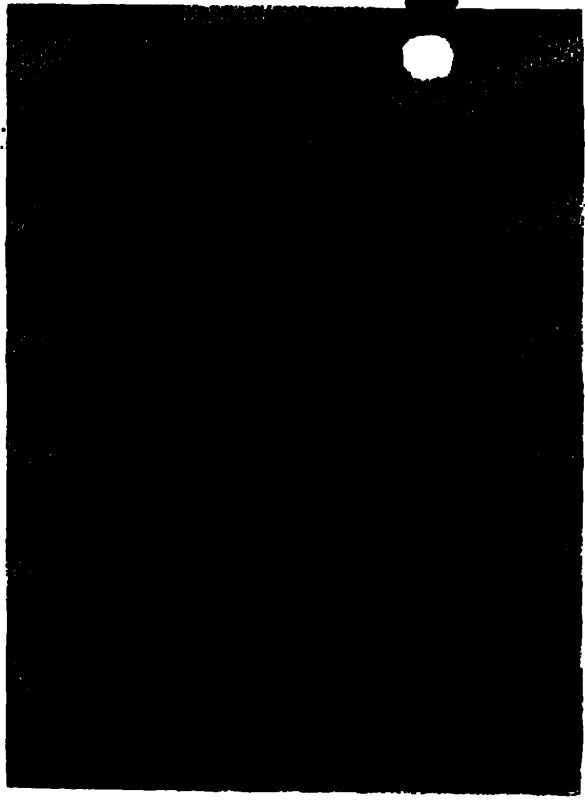

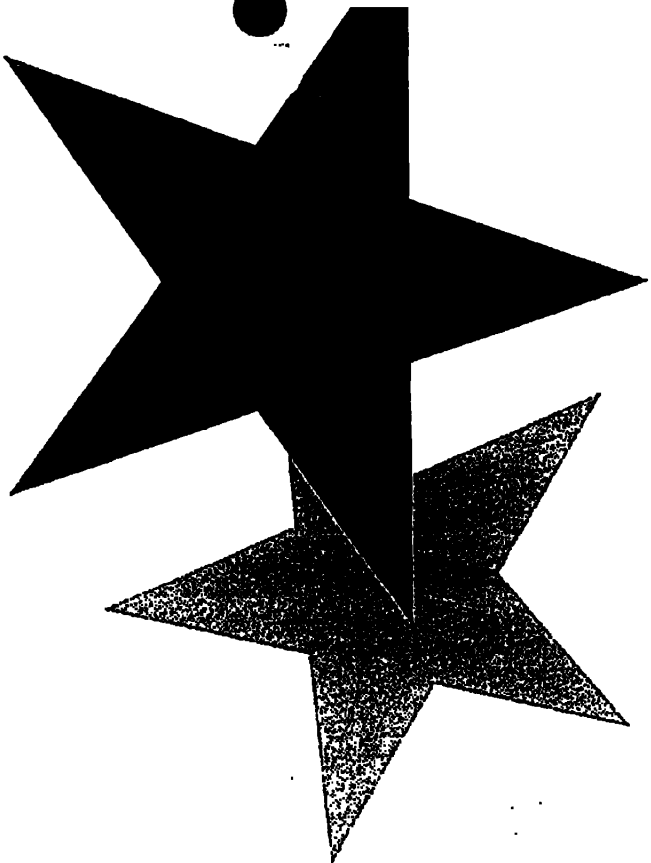
