Further to your letter of 6 November 2008, and my letter to your office of 12 November 2008, I have researched online FEC records concerning the allegations contained in the 30 October 2008 letter to you from the law firm of Baker and Hostetler.

I want to clarify first of all that the candidate, David Robinson, also known as David W. Robinson, living at [redacted] Columbus, OH 43215, is not related to me. I will refer to him below as Candidate Robinson. Because my former address was [redacted], Worthington, OH 43085, I am referred to as "Robinson of Worthington" in Mr. Preisse's complaint.

After researching online FEC records carefully, I note that the Robinson for Congress Committee has filed amended reports detailing all the campaign contributions, disbursements and debts referred to in Mr. Preisse's complaint. Details follow below.

a. In the July [2008] Quarterly Financial Report, Schedule A, line 11D, and Schedule B, line 10, the Robinson for Congress campaign attributed three donations and three disbursements to me. The amounts were \$380.00, \$460.00, and \$2500.00. In addition, in Schedule D, a debt in the amount of \$5000 is attributed to me. In the amended report, known as FEC-402335, all these items are now attributed to Candidate Robinson, residing at 816 Summit St., Columbus.

b. In the October Quarterly Report, Schedule B, a disbursement to me in the amount of \$1000 for video production was attributed to me. In the amended report, known as FEC-402614, this disbursement is attributed to Candidate Robinson. Another item found in FEC-381294, Schedule D, line 10, an October report showing a debt of \$4000.00, is attributed not to me but to Candidate Robinson.

c. As to the remaining item in the Preisse complaint, in Schedule B of the Pre-General Financial Report, a disbursement to me of \$225 for postage is reported. In the amended report, known as FEC-402616, this item is attributed to Candidate Robinson.

I certify that I have not made any donations to, received any disbursements from, or had any connection with the Robinson for Congress campaign. I further certify that I have never lived anywhere on Summit St., Columbus, OH.

I have no idea why my name and address were ever mentioned in the earlier reports from the Robinson for Congress campaign. The reports referenced above show that I have absolutely no connection with Candidate Robinson's campaign. Accordingly, I respectfully request that the file against me be closed.
