Dear Sir:

We are in possession of the above numbered complaint. Our understanding, Mr. Paul Ware specifically complained of an attached door hanger claiming it advocated the election of two federal candidates, Barack Obama and Rick Noriega. He claimed such were distributed all over Fort Bend County and cost well in excess of \$1,000.00. He further claimed we did not file with the Federal Elections Commission for the reporting of the expenditures for these federal candidates.

As to the factual allegations, Fort Bend Democrats did not file as a Federal Pac to report the costs of the materials as expenditures for any federal candidates. We did not consider ourselves a Federal Pac nor the questioned door hanger directly advocated the election of federal candidates. The door hanger was a political piece advocating, "Vote a Straight Democratic ticket." The overwhelming majority of the content and theme of the piece was calling for the straight democratic ticket and showing voters "how to" vote straight tickets.

Nowhere is there any language urging voters directly or instructing voters how to vote for Barack Obama and Joe Biden. The only mention of Barack Obama's name is in language, pointing out Barack Obama can't change our country without electing races up and down the ballot. It is true Rick Noriega appears one time as part of a slate card of candidates. Nowhere is his name singled out or his issues shown in any detail. As has been stated, this piece was a slate card emphasizing the importance and mechanism of voting a straight democratic ticket.

As to the piece it cost \$2,600.00 with \$214.50 tax, see Exhibit A & B. We believe the slate consisted of 9 candidates. However, if you included Barack Obama, the total would be 10 with 2 being federal candidates. In either event, the expense for this piece for the percentage for federal candidates was far less than \$1,000.00 (i.e. either \$520.00 or \$288.00 depending on percentage use). This piece was not mailed but was distributed

by volunteer labor; no paid distribution by paid labor was utilized. It was typically distributed by block walking lit drops or off tables at campaign headquarters and events.

Accordingly, we did not feel we were a Federal Pac nor did we use funds to advocate for federal candidates. Specifically this political piece in question was a political piece advocating a "Straight Democratic Ticket" vote.
