Dear Ms. Collins:

Foundations Inc. received the complaint designated as MUR 6101 on February 9, 2009.¹ The reason Foundations Inc. is listed in the complaint appears to rest on Mr. Herz's theory "that Foundations, Inc. [sic], November, Inc. [sic], Autumn Productions, and NI Operations are one and the same entity, all likely organized under the parent company November, Inc. [sic]" While Foundations Inc. believes that its alleged relationship with November Inc. is irrelevant to the Commission's determination as to whether Heller for Congress's outstanding debts constitute impermissible contributions, we would appreciate the opportunity to put Mr. Herz's conspiracy theory to rest.

First, contrary to Mr. Herz's assertion that "[o]f these four businesses [identified in the complaint], only November, Inc. [sic] is a registered business entity with the state of Nevada," Foundations Inc. was a corporation registered with the Nevada Secretary of State from May 22, 2003, to March 14, 2007. See Exhibit 1. Foundations Inc. formally changed its name to In Compliance Inc. on March 14, 2007, which may explain why Mr. Herz was unable to locate "Foundations Inc." in Nevada's business entity database. See Exhibit 2. In Compliance Inc., which maintained continuity of business through the name change, is still in operation.

Second, Foundations Inc. and November Inc. are separate and distinct entities. November Inc. is not Foundation Inc.'s parent company, and neither November Inc.

nor any of its principals have an ownership interest in Foundations Inc.² Furthermore, November Inc. and Foundations Inc. maintain separate bank accounts and do not commingle funds.

Finally, Mr. Herz states that "[i]n the reports for the Heller for Congress Committee, Foundations, Inc. [sic], Autumn Productions, and NI Operations all share the following address: PO Box 27972, Las Vegas, NV 89126." During the time period contemplated in the complaint, Foundations Inc. legally shared office space and a post office box with November Inc., Autumn Productions, and NI Operations. Contrary to Mr. Herz's insinuation, and as the Commission is well aware, the Commission's regulations do not prohibit corporations from sharing office space and a post office box.

For the reasons stated above, we believe the Commission should dismiss Mr. Herz's complaint. Thank you very much for your attention in this matter and please do not hesitate to contact me at (214) 292-4071 (telephone) or (214) 747-2091 (fax) with questions or concerns.
