Dear Mr. Jordan,

This letter is submitted in response to your letter (dated July 18, 2008 and received by me on August 2, 2008) addressed to an old address for me and Liberty Service Corp. Our correct address to send future correspondence is: 6415 Summer Grace St, Colorado Springs, CO 80923.

The July 21st complaint filed by Matthew J. Werner with accompanying affidavit of Alan Farnia, is completely without merit.

At no time did I or Liberty Service Corp. (LSC) nor any of its agents, nor Doug Lamborn nor the Lamborn for Congress campaign or any of its agents coordinate election efforts with any of the mentioned parties.

Liberty Service Corp. was contracted with Lamborn for Congress during the 2006 election cycle to perform a variety of general management campaign services including data base management and enhancement.

Liberty Service Corp. contracted with Tactical Data Solutions (TDS) to provide their specialized data management and enhancement services for LSC's data projects.

During the 2006 Election Cycle, neither I nor LSC, nor Doug Lamborn nor Lamborn for Congress ever provided our lists to outside groups or their agents nor expressed the needs, wants, and desires of LSC or the Lamborn campaign to such groups

or their agents.

Contrary to the complaints verbiage, neither I nor LSC directs or controls any of TDS business or efforts with their other clients, nor have I or LSC ever attempted to do so.

This merit less complaint was filed in the last days of the 2008 CD 5 Republican Primary as an election stunt to attack Congressman Lamborn in the media and your government agency to help the election of Jeff Crank.

Matthew Warner is a long time and public Jeff Crank for Congress supporter and donor who has performed election related legal services for Crank for several years.


The conversations that Alan Farina claims he had with me never happened. I am not personally aware of the conversations he claims he had with other parties but I highly doubt their validity. Farina is a discredited, untruthful and disgruntled former employee of TDS who joined with Jeff Crank and Matthew Warner to combine their efforts against their perceived political and professional opponents.

I have spoken directly to a prominent Colorado lobbyist who if requested will sign an affidavit or testify that they spoke directly with Jeff Crank in person prior to the complaints filing about the specific details of his legal strategy, played out in the media and the courts, to discredit Congressman Lamborn and his perceived supporters and thereby help Jeff Crank win the election.

The FEC should dismiss this complaint as merit less and hopefully take added steps in the future to stop the wide-spread abuse of the FEC complaint process by those who use it as an election time weapon to silence or discredit their foes.
