You are in receipt of one original and three copies of a Complaint being brought against the campaign committee of L. David Huffman. Huffman is a candidate for Congress in the 10th District of North Carolina. The Petitioners are Sandy Lyons, Patrick McHenry and George Moretz. All three of these gentlemen faced off with Huffman in the July 20th 2004 Primary. A run-off between Huffman and McHenry will be decided on Tuesday, August 17th.

We respectfully request that your office immediately launch an investigation into the source of funds for the personal loans to Huffman's campaign and the legality of the Ford Explorer raffle. If the appearance of impropriety proves to be true, these candidates/petitioners faced an uneven primary field against a candidate who was using illegal means of financing his campaign.

If we can be of any assistance to you during the course of the investigation, do not hesitate to call on us.

COMPLAINT

NOW COMES Sandy Lyons, Patrick McHenry and George Moretz bringing a Complaint pursuant to 2 U.S.C. § 437g(a)(1) alleging multiple serious violations of the Federal Election Campaign Act and U.S. Criminal Code.

I. SUMMARY

North Carolina Congressional candidate David Huffman ("Huffman") appears to have illegally laundered up to \$266,647.01 through his personal bank account into his federal campaign coffers (these illegally obtained funds comprise more than 60% of the funds used by Huffman during the Primary Election); this allegation is based upon review of the reports Huffman for Congress Committee ("Huffman's Committee") filed with the Federal Election Commission ("FEC") (attached hereto as Exhibit "A": Disbursements April Report; Exhibit "B": Loans April Report; Exhibit "C": Disbursements July Report; Exhibit "D": Loans July Report), the Financial Disclosure Statement David Huffman filed with the U.S. House of Representatives (attached hereto as Exhibit "E") and statements made by David Huffman to various newspapers (attached hereto as Exhibit "F"). These funds received by Huffman in the form of uncollateralized, undocumented, no interest, no due date and still-secret loans constitute unlawful and excessive political contributions. David Huffman has either failed to report receipt of these funds entirely or falsely and fraudulently reported these funds to the FEC as a loan of "personal funds only".

Huffman's Committee appears to have illegally accepted from Dale Jarrett Ford, Inc. in-kind contributions in excess of the maximum allowable contributions from a corporation. These contributions were received by Huffman's Committee in the form of a Ford Explorer valued at \$33,695.00. Further, **it appears that Huffman's Committee may have fraudulently attempted to conceal this illegal \$33,695.00 contribution as an unitemized contribution.**

Huffman's fraudulent campaign filings violate the most basic federal laws and merit a swift FEC investigation and action.

II. FACTS

On January 12, 2004, David Huffman announced his candidacy for the U.S. Congress for North Carolina's 10th Congressional District. Huffman's Committee's April Quarterly FEC Report ("April Report") stated that on January 16, 2004, Huffman loaned his campaign \$6,647.01 from his personal funds (attached hereto as Page 1 of 3 of Exhibit "B"). This loan is astonishingly close in number to

the "Cash on Hand at End" of the Committee to Re-elect L. David Huffman Sheriff (attached hereto as Exhibit "H").

Huffman's Committee's April Report further stated that on March 30, 2004, Huffman loaned his campaign \$100,000.00 from his personal funds (attached hereto as Page 3 of 3 of Exhibit "B"). On May 4, 2004, the FEC notified Huffman's Committee of its failure to include required essential information regarding the interest rate and due date of the \$100,000.00 (attached hereto as Exhibit "I"). Huffman's Committee has FAILED to disclose to the FEC the actual source of this \$100,000.00.

Huffman's Committee's July Quarterly FEC Report ("July Report") stated that on May 10, 2004, Huffman loaned his campaign \$50,000.00 (attached hereto as Page 1 of 3 of Exhibit "D"). For the second time, Huffman's Committee FAILED to disclose to the FEC the actual source of this \$50,000.00. Huffman's Committee's July Report stated that on June 9, 2004, Huffman loaned his campaign \$10,000.00 (attached hereto as Page 2 of 3 of Exhibit "D"). For the third time, Huffman's Committee FAILED to disclose the actual source of this \$10,000.00. Huffman's Committee's July Report stated that on June 17, 2004, Huffman loaned his campaign another \$100,000.00 (attached hereto as Page 3 of 3 of Exhibit "D"). For the fourth time, Huffman's Committee FAILED to disclose the actual source of this \$100,000.00.

On July 18, 2004, The Hickory Daily Record reported David Huffman as stating \$166,000.00 of the money he has loaned his campaign "came from a bank loan" (attached hereto as Exhibit "F"). This statement directly contradicts what Huffman's Committee has reported to the FEC. Again, Huffman's Committee has reported to the FEC that money Huffman loaned his campaign came from Huffman's personal funds (see of Exhibits "B" and "D").

On July 18, 2004, The Hickory Daily Record reported David Huffman as stating that \$100,000.00 of the money he has loaned his campaign he borrowed "against his retirement earlier this year" (attached hereto as Exhibit "F"). However, Huffman stated in the Financial Disclosure Statement he filed with the U.S. House of Representatives his ONLY LIABILITY as being a \$25,500.00 mortgage on his vacation home, (attached hereto as Page 5 of 6 of Exhibit "E"). And, once again, Huffman's Committee has reported to the FEC that money Huffman loaned his campaign came from Huffman's personal funds (Exhibits "B" and "D").

On or before May 29, 2004, Huffman's Committee began advertising the raffling of a 2004 Ford Explorer valued at \$33,695.00 (attached hereto as Exhibit "J"). However, Huffman's Committee's April and July Reports do NOT disclose a disbursement for the purchase of the 2004 Ford Explorer. (see Exhibits "A" and "C").

III. THE LAW and APPLICATION

- 1. The Secret \$266,647.01 Loans Constitute Campaign Contributions Far in Excess of the Amount Allowed by Law and Were Illegally Misreported to the FEC.***

A bank loan to a candidate finance his campaign will be considered a contribution and subject to contribution limits, unless it:

- (1) Bears the usual and customary interest rate of the lending institution for the category of loan involved;
- (2) Is made on a basis that assures repayment;
- (3) Is evidenced by a written instrument; and
- (4) Is subject to a due date or amortization schedule.

11 CFR 100.82(a).

All loans made by a candidate to his authorized committee including loans derived from a bank loan to the candidate shall be disclosed to the FEC. 11 CFR 104.3(a)(3)(vii)(B). When a candidate obtains a bank loan for use in connection with the candidate's campaign, the candidate's committee shall disclose to the FEC the following information:

- (1) The date, amount, and interest rate of the loan, advance, or line of credit;
- (2) The name and address of the lending institution; and
- (3) The types and value of collateral or other sources of repayment that secure the loan, advance, or line of credit, if any.

11 CFR 104.3(d)(4).

"A gift, subscription, loan (except for a loan made in accordance with 11 CFR 100.72 and 100.73), advance, or deposit of money or anything of value made by any person for the purpose of influencing any election for Federal office is a contribution." 11 CFR 100.52(a). "A loan that exceeds the contribution limitations of 2 U.S.C. 441a and 11 CFR part 110 shall be unlawful whether or not it is repaid." 11 CFR 100.52(b)(1).

David Huffman's third party – uncollateralized, undocumented, no interest, no due date – loans were NOT arms-length transactions made on usual and customary terms. The third party loans were illegal contributions that were made for the purpose of influencing the outcome of the election.

Federal criminal law further prohibits individuals from knowingly and willfully "mak[ing] any false, fictitious or fraudulent statements or representations... within the jurisdiction of any department or agency of the United States." 18 U.S.C. § 1001. The FEC is an "agency" within the meaning of section 1001, see *U.S. v. Crop Growers Corp.*, 954 F.Supp 335, 354 (D. D.C. 1997), and each violation of this criminal statute could result in a fine of up to \$10,000.00, imprisonment for up to five years, or both. *Id.*

David Huffman's reporting the \$266,474.01 infusion into his campaign as a loan of "personal funds only" is false, fraudulent and fictitious. These funds were not his own as evidenced by Huffman's statements to the press and the Financial Disclosure Statement he filed with the U.S. House of Representatives (see Exhibits "E" and "F"). Huffman's filing is knowingly inaccurate and violates the U.S. criminal code. 18 U.S.C. § 1001.

2. The \$33,695.00 Car Raffle Proceeds Constitutes an Excessive Political Contribution that Should Have Been Reported to the FEC.

The donation of goods offered free or at less than the usual charge is called an in-kind contribution. See *Campaign Guide for Congressional Candidates and Committees*, <http://www.fec.gov/pages/candguide2004/chapt3.htm>, (March 2004 Edition) citing 11 CFR 100.52(d)(1). The value of an in-kind contribution – the usual and normal charge – counts against the same contribution limit as a gift of money. *Id.*

Huffman's Committee's acceptance of 2004 Ford Explorer constituted an in-kind contribution that was excessive and illegal. The illegal in-kind contribution of 2004 Ford Explorer was received on or before May 29, 2004, as evidenced by Huffman's Committee's advertising of the car raffle at The Greater Hickory Smoke on May 29, 2004 (see Exhibit "J"). However, Huffman's Committee's April and July Reports, which disclose all receipts and disbursements up through and including July 15, 2004, do not disclose the receipt of this illegal in-kind contribution nor a disbursement for the purchase of the 2004 Ford Explorer (see Exhibits "A" and "C").


V. PRAYER FOR RELIEF


David Huffman's verifiable written contradictions regarding the financing of his campaign and his refusal to disclose to the FEC the source of more than 60% of his campaign funds makes a public mockery of campaign finance laws and shreds the most basic ethical requirements required of candidates. **When questioned about his failure to disclose the source of the \$266,647.01 Huffman stated, "How can that be a lot of money in this day and time?"** (see Page 6 of Exhibit "F"). It is "a lot of money" to the vast majority of voters in North Carolina's 10th Congressional District; and, apparently, as evidenced by Huffman's Financial Disclosure Statement, it should be considered "a lot of money" to him (see Exhibit "E"). That a candidate would even consider financing his campaign in such a way raises serious questions about his judgment, character and respect for the law – questions properly put before the voters of North Carolina's 10th Congressional District.


But Huffman's apparent violations of the law are properly brought before the Federal Election Commission and/or Department of Justice. Therefore, Sandy Lyons, Patrick McHenry and George Moretz respectfully request that the Commission fully investigate the campaign activities of the Huffman for Congress Committee with particular emphasis upon the unreported, excessive and unlawful third-party contributions that have come in the form of loans and payments to the candidate. Criminal violations should be referred to the Department of Justice's Public Integrity section.







High stakes

Candidates ante up \$1.4 million of their own money in Republican primary.

HICKORY -- Republican candidates in the 10th District Congressional race are playing a high-stakes game of political poker, betting their own money that they'll be victorious this week.

The four candidates combined to raise more than \$2.3 million as of the end of June. Of that amount, \$1.4 million came from their pockets.

Leading the group is George Moretz, chairman of Carolina Mills. He had raised nearly \$1 million, of which \$760,000 he contributed or loaned his campaign.

Since the beginning of the month, Moretz invested another \$140,000 into his campaign.

While Moretz has anted the most, Catawba County Sheriff David Huffman may be the local candidate with the most at stake.

He borrowed \$266,000, more than 60 percent of his \$423,543 raised, to help fund his campaign.

Huffman borrowed \$100,000 against his retirement earlier this year, he said. He says another \$166,000 came from a bank loan.

Another politician with much in the pot is N.C. Rep. Patrick McHenry, who loaned his campaign \$96,000 of the \$266,000 raised.

Sandy Lyons, former chief executive officer of Corning Cable Systems, loaned his campaign \$345,000 of the \$656,000 raised.

For Moretz, his investment was a little more money than initially expected.

"It's probably more money than I anticipated when I entered the race," he said.

Irritated by U.S. Rep. Cass Ballenger's support of some free trade agreements, Moretz threw his hat in the ring last fall.

He did so with little name recognition. In facing David Huffman, he opposes someone with 26 years of political experience.

"It is quite a challenge to overcome that head start," Moretz said.

He has relied on television and radio advertising for months.

Moretz said his business duties deny him the ability to perform grass-roots campaigning.

"I've had to use the media to get the message out," he said. "My campaign has probably been more expensive than the others for that reason. I want to say that I've done everything that I could to win this race."

Huffman said his personal investment is a display of commitment.

"I've received money from people who can't afford to give me money," Huffman said.

"I feel obliged to put my money in with theirs."

Huffman said the investment is a show of confidence that he will win.

Elected officials can hold fund-raisers to pay themselves back the money they loaned their campaigns, but only up to \$250,000.

"We have to take a chance to win and make a difference," Huffman said.

McHenry, 28, said the money put a burden on him financially.

"I want people to see that I'm contributing as much time and as much money as I can," he said.

"It certainly is a risk, but I believe so much in what I'm fighting for, I'm willing to put a lot on the line."

Lyons started and sold his own business in the 1990s, so putting his share of the money up wasn't as taxing. He doesn't view it as a gamble.

"I consider it a commitment to the campaign," he said. "It's not a good business decision, but it's the right decision."

The candidates understand the winner could spend years in office serving the Republican-dominated district. Only two politicians, both Republicans, have represented the 10th District during the past 40 years.

U.S. Rep. Cass Ballenger has served since 1986. Before him, Jim Broyhill held the position for 24 years.

Neither was ever seriously threatened in re-election bids.

This year's Democratic candidates, John Cole and Anne Fischer, on the other hand, have yet to file federal campaign reports, meaning they have not raised at least \$5,000.

of \$423,543

\$100,000 against his retirement earlier this year, he said. He says another \$100,000 came from a bank loan.

Another politician with much in the pot is N.C. Rep. Patrick McHenry, who loaned his campaign \$96,000 of the \$266,197 raised.

Sandy Lyons, former chief executive officer of Corning Cable Systems, loaned his campaign \$345,000 of the \$656,867 raised.

For Moretz, his investment was a little more money than initially expected.

"It's probably more money than I anticipated when I entered the race," he said.

Irritated by U.S. Rep. Cass Ballenger's support of some free trade agreements, Moretz threw his hat in the ring last fall.

He did so with little name recognition. In facing David Huffman, he opposes some-

one with 26 years of political experience.

"It is quite a challenge to overcome that head start," Moretz said.

He has relied on television and radio advertising for months.

Moretz said his business duties deny him the ability to perform grass-roots campaigning.

"I've had to use the media to get the message out," he said. "My campaign has probably been more expensive than the others for that reason. I want to say that I've done everything that I could to win this race."

Huffman said his personal investment is a display of commitment.

"I've received money from people who can't afford to give me money," Huffman said. "I feel obliged to put my money in with theirs."

Huffman said the investment is a show of confidence that he will win.

Elected officials can hold fundraisers to pay themselves back the money they loaned their campaigns, but only up to \$250,000.

"We have to take a chance to win and make a differ-



Candidates collect more than \$3 million

10th District Congressional candidates raised more than \$3 million in the past six months.

The campaign season is reaching its "primary" point, and so far, Republican candidates for the 10th Congressional district have boosted election efforts with more than \$1.3 million in contributions and loans.

These contributions haven't just come from Catawba County and the 10th District. They have come from all over the U.S., with fund-raising leader Sandy Lyons (\$1,072,000.35) receiving donations from throughout the Southeast and the nation. Campaign contributions thus far have been documented closely by the Federal Election Commission, which required quarterly contribution reports for the quarters ending March 31 and June 30. Now, as the race heats up, candidates seeking the GOP Congressional nomination are reporting contributions thus far this year, including services, amount to

himself.
To date, these public reports indicate that candidates for the 10th Congressional district have received \$2,339,248.46.

Following is an analysis of each candidate's fund-raising reports, listed in the order they will appear on the July 20 primary ballot.

David Huffman

Catawba County Sheriff
David Huffman's total contributions thus far this year, including services, amount to

\$421,990.57.

Within the most recent quarter, running from April 1-June 30, Huffman received total donor contributions worth \$97,736. However, his net operating expenses amounted to \$230,896.55. Huffman himself made or guaranteed a \$180,000 loan to his campaign.

For this quarter, Huffman's receipts in donations, loans, political action committee contributions and services for the past quarter equaled \$251,736. During the past two quarters, Huffman's donations have

Huffman's donations have come primarily from within North Carolina. He received 56 contributions from Hickory, eight from Morganton, four from Catawba, three from

Maiden, eight from Claremont and 39 from Concord. He received 29 donations from Newton, two from Marion, two from Mooresville, five from Denver, two from Vale, three from Lenoir, one from Blowing Rock, two from Lincolnton, one from Washington, D.C., two from Louisiana and one each from Georgia and Alabama. Huffman also received one each from Granite Falls, Burnsville, Stanley, Clinton, Taylorsville, Wilmington and Silver City, Stanley, Spruce Pine, Winston-Salem and Eden.

Since the implementation of the 48-hour rule on July 1, Huffman has received four donations, each in the amount of \$1,000.

Within the first quarter, which ran from Jan. 1-March 31, Huffman reported \$54,300 total contributions other than loans. Huffman already spent a large portion of this money, with a reported \$40,271.19 net operating expenditures. During this quarter, Huffman made or guaranteed a loan of \$108,747.01 to his campaign. His total receipts for the quarter amount to \$161,603.57.

Sandy Lyons

Candidate Sandy Lyons' has received a total of \$1,072,059.35 in reported contributions thus far.

During the most recent quarter, Lyons reported \$407,170.78 in net contributions, with \$139,150.44 in net operating expenditures. With Lyons not making any loans or guarantees to his campaign, his total receipts for the second quarter amounted to \$407,171.80.

Unlike Huffman, Lyons' campaign contributions ranged across the U.S. He received 109 from Hickory, four from Newton, five from Shelby five from Claremont, two from Charlotte, two from Taylorsville, four from Catawba, two from Lenoir, and two from Lincolnton. He received two from Sherrills Ford and two from Cherryville. Lyons also received one each from Statesville, Winston-Salem, Granite Falls, Vale, Hudson, Mount Airy, Blowing Rock, Derrell, Union Mills and Albright.

From the rest of the nation, Lyons has received five contributions from Ohio, three from South Carolina, 10 from New York, nine from Virginia, two from Maryland, two from Alabama, two from Pennsylvania, 3 from Washington, D.C., two from Massachusetts and two from Illinois. He received one each from Wisconsin, Missouri, Connecticut, New Jersey, Arizona, Minnesota, New Hampshire and Rhode Island, Alabama, Texas, Arkansas and Florida.

Sandy Lyons has reported 332 donations since July 1, totaling \$5,479. All three came from people who reside in Virginia.

During the first quarter of the year, he received \$454,327.54 in net contributions, with net operating expenditures equaling \$4,915.60. Lyons didn't make any loans or guarantees to his campaign during this quarter, but, so his total receipts totaled \$459,243.14.

Patrick McHenry

Current North Carolina Rep. Patrick McHenry's reported campaign donations for the year equal \$465,723.62.

Although McHenry hasn't reported any contributions since the 48-hour rule was put into place, he did report net contributions of \$165,960.22 from the second quarter, and net operating expenditures of \$180,709.23. McHenry has also made or guaranteed a loan of \$96,000 to his campaign, bringing his total receipts up to \$262,950.22.

Like Lyons, McHenry requested several contributors from across the U.S. during the first quarter, although he still had several from the western part of the state. McHenry received 78 from his home base in Gastonia, four from Shelby, five from Kings Mountain, nine from Charlotte, nine from Raleigh, three from Dallas and three from Dunn. He received eight contributions from Cherryville, five from Cranston two from Cranston, two from New Bern, four from Lake Lure, six from Belmont, and two from Marble. McHenry received one each from Morganton, Concord, Forest City, Newton, Hickory, Concord, Apex, Winston-Salem, Ashburn, Wake Forest, Hamptonville and Eden.

He received four from Washington, D.C., two from Virginia and one each from Nevada, Missouri, South Carolina, Louisiana, Illinois, Delaware, California and Georgia.

In the first quarter, McHenry reported \$117,773.20 in total contributions, other than loans, for the first quarter of 2004, with net operating expenditures equaling \$60,167.40. McHenry made or guaranteed a loan of \$85,000 to his campaign. He reported a total of \$202,773.20 receipts for the quarter.

George Moretz

George Moretz reported campaign contributions for the year of \$1,378,064.22.

He reported \$294,543 in net contributions and \$809,301.86 in net operating expenditures for April 1-June 30. Moretz also made a hefty loan or guarantee of \$735,000 to his campaign, bringing his total receipts to \$969,722.64.

Of those who donated to his campaign 85 were from Hickory, eight were from Shelby, nine were from Burlington, three were from Cherryville, three were from Maiden, seven were from Concord, and 13 were from Charlotte. Moretz received three contributions from Linville, two from Gastonia, seven from Newton, two from Lincolnton, seven from Kings Mountain, four from Winston-Salem, two from Blowing Rock, and two from Belmont. He also received one each from Raleigh, Lenoir, Whitsett, Mooresville, Durk, Lincolnton, Valdese, Eden, Greensboro, Morganton and Asheville.

He received four contributions from Tennessee, three from Florida and one each from California, New York, Rhode Island, Utah, South Carolina, Georgia, Connecticut, Washington, D.C., Massachusetts, Pennsylvania, Missouri and New Jersey.

George Moretz reported \$33,700 in donations to his cam-

paign since July 1, with \$25,000 of that amount being donated by himself to his campaign.

Moretz also received \$158,634 in contributions from the beginning of January through March 31. He spent \$340,691.03 in total operating expenditures, and made or guaranteed a \$196,000 donation to his campaign for the quarter. His total

receipts equal \$344,641.58.

The two Democratic candidates were not listed on the FEC's Web site as having received any money since the new rule went into effect in July. Nor was any information posted about any of their contributions from the two quarters for they year. For more information, visit their Web site at www.fec.gov.

Lawmakers weigh in on 10th race

Group backed by GOP officials runs ad blasting 3 candidates in primary

In the race to succeed Republican U.S. Rep. Cam Riffe, even fellow Republican congressmen from around the country

have gotten into the act.

A group backed by moderate GOP lawmakers began airing radio ads Friday attacking three of the four candidates in Tuesday's Republican primary.

It's the latest salvo in a contest almost certain to decide the next members of Congress from the 10th District. Riffe is retiring after nine terms in the Western North Carolina district that includes Lincoln, Catawba and Cleveland counties. Though two

Democrats are running, the district tilts strongly Republican.

So it's no surprise the race is among the nation's most expensive. The nearly \$2 million spent by the four is more than in all but six races across the country.

All the candidates have dug into their own pockets. That contributed this week to George Moretz, CEO of Carolina Mills in Maiden, on Thursday put an additional \$140,000 into his campaign, for a total of \$924,000.

Sandy Lyons, 47, has loaned his campaign \$448,000. Rep. Patrick McHenry, a 28-year-old legislator from Cherryville, has put \$96,000 into his race.

But it was Catawba County Sheriff David Hoffman's loan to his campaign of \$186,000 that raised eyebrows at the Republican Main Street Partnership, a political action committee allied with the group of conservative Republicans that includes 70 mem-

The ad says Hoffman's campaign finance reports "raise lots of concern." Springfield, Mass., Mayor Kerry Kuntz, whose group supports Lyons, said Hoffman's loan "raised some red flags."

Hoffman's personal financial disclosure shows he made about \$812,000 last year. His biggest source: a \$480,000 gift on IRA, each with assets ranging from \$80,000 to \$250,000.

Hoffman said Friday a loan that size is "not unusual."

"How can that be a lot of money in this day and time?" he asked. "Voters in this district are just tired of these things. And I don't think it will have any impact on this election."


The ad isn't the first time members of Congress have figured into the race.

At a forum in Hickory last month, Hoffman attacked the eight GOP congressmen who had endorsed Lyons, former president of Carolina Cable Systems in Hickory. He suggested their support was a result of campaign contributions from Carolina's parent company.

"I can't buy congressmen like that," Hoffman said at the time.

Hoffman, who also has endorsed Lyons, said at the time he was "shocked and angered" by Hoffman's "recklessness and baseless attack" against his eight colleagues.

The 10th District has been among the region's hardest hit economically. Outbacks in tax-

ties, furniture and other cycles have cost 40,000 people their jobs. Through March, Catawba had lost more manufacturing jobs - 9,200 - than any county in the state. Candidates have talked jobs. But in appealing to conservative voters, they've also talked about values and emphasized their religious beliefs.

As for Lyons' support from sitting members of Congress, he says he's not embarrassed.

"I've been doing that in order to develop those relationships," he says. "As if I'm the person chosen to represent this district I can hit the ground running."



Congressional television ads have run for weeks.

While the official start of the 10th District Congressional race begins this week, the "true" contest began months ago.

Four declared Republican candidates raised a combined \$1.1 million and spent more than half that amount by April.

It's likely to only get more expensive.

To be serious candidate, you have to raise three quarters of "million," said Anne Parsons, campaign manager

secure the 30 percent necessary to avoid a runoff among the top two vote-getters.

Joseph Mancos, a political science professor at Lenoir-Rhyne College, believes it's likely each candidate could garner at least 15 percent of the vote.

"It seems like we could very well end up in a runoff," Mancos said.

In recent contested House races across the country, Mancos said, the average amount spent by the winner was \$400,000. The loser's average was \$200,000.

CHAPTER I--FEDERAL ELECTION COMMISSION

PART 100_SCOPE AND DEFINITIONS (2 U.S.C. 431)--Table of Contents

Subpart A_General Definitions

Sec. 100.33 Personal funds.

Personal funds of a candidate means the sum of all of the following:
(a) Assets. Amounts derived from any asset that, under applicable State law, at the time the individual became a candidate, the candidate had legal right of access to or control over, and with respect to which the candidate had--

- (1) Legal and rightful title; or
- (2) An equitable interest;
- (b) Income. Income received during the current election cycle, as defined in 11 CFR 400.2, of the candidate, including:
 - (1) A salary and other earned income that the candidate earns from bona fide employment;
 - (2) Income from the candidate's stocks or other investments including interest, dividends, or proceeds from the sale or liquidation of such stocks or investments;
 - (3) Bequests to the candidate;
 - (4) Income from trusts established before the beginning of the election cycle as defined in 11 CFR 400.2;
 - (5) Income from trusts established by bequest after the beginning of the election cycle of which the candidate is the beneficiary;
 - (6) Gifts of a personal nature that had been customarily received by the candidate prior to the beginning of the election cycle, as defined in 11 CFR 400.2; and
 - (7) Proceeds from lotteries and similar legal games of chance; and
- (c) Jointly owned assets. Amounts derived from a portion of assets that are owned jointly by the candidate and the candidate's spouse as follows:
 - (1) The portion of assets that is equal to the candidate's share of the asset under the instrument of conveyance or ownership; provided, however,
 - (2) If no specific share is indicated by an instrument of conveyance or ownership, the value of one-half of the property.

Unlike previous election cycles, you will not receive an additional notice from the Commission on this matter. Adequate responses received on or before this date will be taken into consideration in determining whether audit action will be initiated. Requests for extensions of time in which to respond will not be considered. Failure to provide an adequate response by this date may result in an audit of the committee. Failure to comply with the provisions of the Act may also result in an enforcement action against the committee.
