1. Mike Miller for Congress has not raised or spent \$40,000.
2. As Mr. Northington has stated in his letter, I have run two previous times and we kept our signs from the last two campaigns, all yard signs and road signs, these signs have been paid for previously, what I have said out campaigning is that we have nearly 40,000 dollars in signs and infrastructure to win this campaign.
3. We did purchase a billboard on July 15, 2008 for \$2,343.00 but that had not put us over the threshold of \$5,000.00. Nor did the purchase of palm cards to pass out to constituents, that cost was \$1060.00.
4. My website was designed by myself and family and a domain name was purchased for \$120.00 for the year our website may look expensive but it is because I try to operate with a spirit of excellence.

It was not until August the 11th did we go over the threshold of \$5,000.00, at which time I did notify the FEC and asked for papers to file for statement of organization. After the papers arrived by mail we filed on the 18th of August 2008 in the name of Friends for Mike Miller.

An FEC form 3 is now being prepared. To date (September 25, 2008) the campaign has not raised and spent over \$20,000. I ask that this continue to remain confidential in accordance with the FEC laws which govern, and no action be taken on this matter. We are clearly trying to act in accordance with the law. Mr. Northington put his own dollar figure on what we were doing. Since receipt of this letter our primary for Delaware is over and we have lost this race and no more active campaigning is taken place. Our final FEC report will follow this letter within a week.

Complaint to Federal Elections Commission regarding Micheal Miller for Congress (D) at-large.

Complainant: Jerry Northington, Northington for Congress

This complaint is lodged against Candidate Micheal Miller and Friends of Mike Miller, Mr. Miller's campaign organization.

Micheal Miller is running in the Democratic primary for Delaware's at large congressional seat. Mr. Miller has publicly stated that he has raised in excess of \$40,000 for his campaign. He has purchased various campaign materials such as palm cards, large highway signs, and smaller lawn signs. In addition, Mr. Miller has rented billboards and placards on city busses. Mr. Miller also maintains a website (www.mikemillerforcongress.com) promoting his candidacy.

All of the above listed materials were either purchased or donated; meaning all of them required disclosure to the FEC. The complainant has personally seen each of these materials.

As of September 4th, 2008, neither Mr. Miller, nor his campaign committee, has filed any of the required FEC documents. He has consistently missed filing deadlines. Mr. Miller has run a federal campaign twice before and should be aware of pertinent campaign finance laws.

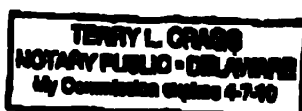
