I believe that there has been a violation of the Federal Election Campaign Laws by the respondent John Campbell's Congressional Campaign in the 48th Congressional District.

The September 2010 issue of the magazine Orange County Jewish Life featured an advertisement from Congressman Campbell. I believe that this advertisement was in violation of the FEC's Disclaimer Notice since it was a "public communication" as defined by the FEC.

Congressman Campbell's Congressional office was contacted on September 8th, 2010 to inquire about the advertisement's funding, and I was told that the funding came from John Campbell's Congressional re-election campaign, which I believe is a clear violation of the FEC's Disclaimer Notice.

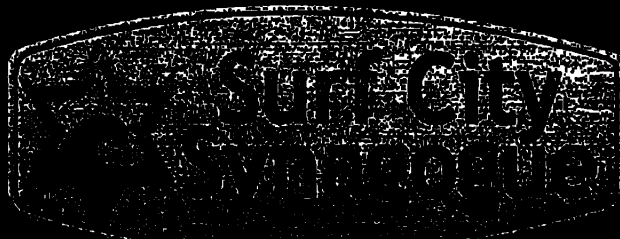

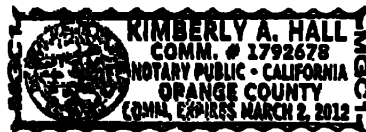

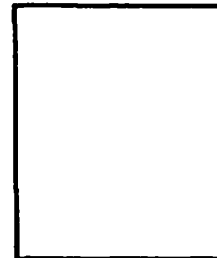
